DECLARATION OF EXISTING PROVINCIAL ROADS — (I) PROVINCIAL ROAD 71 SECTION 7, (II) PROVINCIAL ROAD P4 SECTION 3, (III) PROVINCIAL ROAD P117 SECTION 1, (IV) PROVINCIAL ROAD P34 SECTION 3, (V) PROVINCIAL ROAD P34 SECTION 3, (VI) PROVINCIAL DISTRICT ROAD D433, (VII) PROVINCIAL ROAD P13 SECTION 2, (VIII) PROVINCIAL DISTRICT ROAD D147, (IX) PROVINCIAL ROAD P28 SECTION 3 (X) PROVINCIAL ROAD P28 SECTION 2, (XI) PROVINCIAL ROAD P29 SECTION 1, (XII) PROVINCIAL ROAD P28 SECTION 1 AS NATIONAL ROAD N14 — DISTRICTS OF KUDUMANE, VRYBURG, DELAREWILLE, LICHTENBURG, COLIGNY, VENTERSDORP,

By virtue of section 40(1)(a) of the South African National Road Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare (I) the Section of Provincial Road 71 Section 7 also known as N14, commencing from the North West/Northern Cape Provincial Border, up to Vryburg, (II) the Section of Provincial Road 4 Section 3 also known as N14, continuing from the junction with Provincial Road 72 Section 2 up to the junction with Provincial Road P117 Section 1, (111) the Section of Provincial Road P117 Section 1, also known as N14. continuing from the junction with Provincial Road 4 Section 3 up to Delareyville, (IV) the Section of Provincial Road P34 Section 3, also known as N14, continuing from Delareyville up to Roosville (Sannieshof), (V) the Section of Provincial Road P34 Section 3, also known as N14, continuing from Roosville (Sannieshof) up to junction with Provincial District Road D433, (VI) the Section of Provincial District Road D433, also known as N14, continuing from the junction with Provincial Road P34 Section 3 up to the junction with Provincial Road P 13 Section 2, (VII) the Section of Provincial Road P 13 Section 2, continuing from the junction with Provincial District Road D433 up to the junction with Provincial District Road D147, (VIII) the Section of Provincial District Road D147, continuing from the junction with Provincial Road P 13 Section 2 up to the junction with Provincial Road P28 Section 3, (IX) the Section of Provincial Road P28 Section 3, continuing from the junction with Provincial District Road D147 up to where it joins Provincial Road P28 Section 2, (X) the section of Provincial Road P28 Section 2, continuing from where it joins Provincial Road P28 Section 3 up to where it joins Provincial Road P229 Section 1, (XI) the Section of Provincial Road P229 Section 1, continuing from where it joins Provincial Road P 28 Section 2 up to where it joins Provincial Road P28 Section 1, (XII) the Section of Provincial Road P28 Section 1, continuing from where it joins Provincial Road P 229 Section 1 up to the intersection with the North West/Gauteng Provincial Border, as described in the Annexure hereto, as a National Road.

(i) Description of existing proclaimed Provincial Road P71-7 between the North West/Northern Cape Provincial Border and Huhudi (Vryburg).

The Section of Route N14, also known as Provincial Road P71-7 as previously declared by Administrative Notices as Provincial Road, commencing from the intersection with the North West/Northern Cape Provincial Border, also being the Eastern border of the farm Pakhane 165, there from on proceeding in a general North-Easterly directing on the existing Provincial Road P71-7 up to a point in line with the Southern boundary of South Street, South of Huhudi (Vryburg), where it terminates.

[North West/North Cape Provincial Border - Huhudi (Vryburg)]

(II) Description of existing proclaimed Provincial Road P4-3 between Huhudi (Vryburg) and its junction with Provincial Road P117 Section 1

The Section of Route N14, also known as Provincial Road P4-3 as previously declared by Administrative Notices as Provincial Road, again commencing from its junction with Provincial Road P72-1 on the farm Bernauw 674, East of Huhudi (Vryburg), there from on proceeding in a general North-Easterly directing on the existing Provincial Road P4-3 up to the junction with Provincial Road P117-1 on the farm Broedersput 213 IO.

[Huhudi (Vryburg) - Broedersput]

(III) Description of existing proclaimed Provincial Road P I17 Section 1 between the junction with Provincial Road 4-3 and Delareyville.

The Section of Route N14, also known as Provincial Road P117-1 as previously declared by Administrative Notices as Provincial Road, continuing from its junction with Provincial Road P4-3 on the farm Broedersput 213 IO, there from on proceeding in a general North-Easterly direction on the existing Provincial Road P117-1 up to the junction with Provincial District Road D2430 on the farm Driekant 204 – IO, South of Delareyville, where it terminates.

(Broedersput - Delareyville)

(IV) Description of existing proclaimed Provincial Road P34-3 between Delareyville and Roosville (Sannieshof).

The Section of Route N14, also known as Provincial Road P34-3 as previously declared by Administrative Notices as Provincial Road, again commencing from its junction with Provincial District Road D1699 on the farm Zoutpan or Bospan 203 – IO, North of Delareyville, there from on proceeding in a general North-Easterly direction on the existing Provincial Road P34-3 up to the junction with Provincial District Road D653, also known as Route R375, on the farm De Klipdrift 295 IO West of Roosville (Sannieshof), where it terminates.

[Delareyville - Roosville (Sannieshof)]

(V) Description of existing proclaimed Provincial Road P34-3 between Roosville (Sannieshof) and its junction with Provincial District Road D433.

The Section of Route N14, also known as Provincial Road P34-3 as previously declared by Administrative Notices as Provincial Road, again commencing from its junction with Provincial District Road D655 on the farm Dwaalkraal 291 – IO, East of Roosville (Sannieshof), there from on proceeding in a general Northerly direction on the existing Provincial Road P34-3, through Biesiesvlei up to the

junction with Provincial District Road D433 on the farm Biesjesvallei 149 - IO, North of Biesiesvlei

[Roosville (Sannieshd) - Biesiesvlei]

(VI) Description of existing proclaimed Provincial District Road D433 between Biesiesvlei and its junction with Provincial Road P13-2.

The Section of Route N14, also known as Provincial District Road D433 as previously declared by Administrative Notices as Provincial Road, continuing from its junction with Provincial Road P34-3 on the farm Biesjesvallei 149 – IO, North of Biesiesvlei, there from on proceeding in a general North-Easterly direction on the existing Provincial District Road D433 up to the junction with Provincial Road P13-2 on the farm Rooijansfontein 89 - IP.

(Biesiesvlei-Rooijansfontein)

(VII) Description of existing proclaimed Provincial Road PI3-2 between its junction with Provincial District Road D433 and its junction with Provincial District Road D147.

The Section of Route N14, also known as Provincial Road P13-2 **as** previously declared by Administrative Notices as Provincial Road, continuing from the junction with Provincial District Road D433 on the farm Rooijansfonein 89 – IP, there from on proceeding in a general Southerly direction on the existing Provincial Road P13-2 up to the junction with Provincial District Road 0147-2 on the farm Rooijansfontein 89 – IP.

(Rooijansfontein - Rooijansfontein)

(VIII) Description of existing proclaimed Provincial District District Road D147 between the junction with Provincial Road P13-2 and its junction with Provincial Road P28-3.

The Section of Route N14, also known as Provincial District Road D147 as previously declared by Administrative Notices as Provincial Road, continuing from its junction with Provincial Road P13-2 on the farm Rooijansfonein 89 – IP, there from on proceeding in a general North-Easterly direction on the existing Provincial District Road 0147 up to the junction with Provincial Road P28-3 on the farm Treurfontein 73 – IP.

(Rooijansfontein - Treurfontein)

(IX) Description of existing proclaimed Provincial Road P28-3 between its junction with Provincial District Road D147 and where it joins Provincial Road P28-2.

The Section of Route N14, also known as Provincial Road P28-3 as previously declared by Administrative Notices as Provincial Road, continuing from its junction with Provincial District Road D147 on the farm Treurfontein 73 – IP, there from on proceeding in a general South-Easterly direction on the existing Provincial Road P28-3 up to where it joins Provincial Road P28-2 on the farm Treurfontein 73 – IP.

(Treurfontein Coiigny)

(X) Description of existing proclaimed Provincial Road P28-2 from where it joins Provincial Road P28-3 to where it joins Provincial Road P229-1.

The Section of Route N14, also known as Provincial Road P28-2 as previously declared by Administrative Notices as Provincial Road, continuing from where it joins Provincial Road P28-3 on the farm Treurfontein 73 = IP, continuing there from on in a general Easterly direction on the existing Provincial Road P28-2, through Coligny Township up to where it joins Provincial Road P229-1 on the farm Elandskuil 206 = IP.

(Coligny - Ventersdorp)

(XI) Description of existing proclaimed Provincial Road P229-1 from where it joins Provincial Road P28-2 to where it joins Provincial Road P28-1.

The Section of Route N14, also known as Provincial Road P229-1 as previously declared by Administrative Notices as Provincial Road, continuing from where it joins Provincial Road P28-2 on the farm Elandskuil 206 - IP, there from on proceeding in a general Easterly direction on the existing Provincial Road P229-1 past Ventersdorp up to where it joins Provincial Road P28-1 on the farm Roodepoort 191 - IP, East of Ventersdorp.

(Ventersdorp* Ventersdorp)

(XII) Description of existing proclaimed Provincial Road P28-1 from where it joins Provincial Road P229-1 to the intersection with the North West/Gauteng Border.

The Section of Route N14, also known as Provincial Road P28-1 as previously declared by Administrative Notices as Provincial Road, continuing from where it joins Provincial Road P229-1 on the farm Roodepoort 191 - IP, there from on proceeding in a general North-Easterly direction on the existing Provincial Road P28-1 up to its intersection with the North West/Gauteng Provincial Border, also being the common boundary between the farms Leeupan 58 - IQ and Bospan 56 - IQ where it terminates.

(Ventersdorp - North West/Gauteng Provincial Border)
