**FEES PAYABLE IN TERMS OF FRIENDLY SOCIETIES ACT, 1956**

I, Trevor Andrew Manuel, Minister of Finance, hereby, after consultation with the Registrar of Friendly Societies, under section 47 of the Friendly Societies Act, 1956 (Act No 25 of 1956), determine the fees set out in the Schedule exclusive of VAT as the fees payable to the said Registrar as contemplated in the said section 47.

This determination is called the Determination of fees payable to the Registrar of Friendly Societies.

The Notice comes into operation on 1 February 2006.
