**NOMINATIONS FROM THE PUBLIC OF PERSONS TO BE APPOINTED AS MEMBERS OF THE COMMITTEE FOR SPATIAL INFORMATION IN TERMS OF THE SPATIAL DATA INFRASTRUCTURE ACT, 2003 (ACT No. 54 OF 2003)**

I, Angela Thokozile Didiza, Minister for Agriculture and Land Affairs, hereby, in terms of section 5 read in conjunction with section 20 of the Spatial Data Infrastructure Act, 2003 (Act No. 54 of 2003), make the regulation as set out in the Schedule hereto.

**SCHEDULE****1. Definition**

In this regulation a word or expression to which a meaning has been assigned in the Act, bears that meaning, unless the context indicates otherwise, and –

“**the Act**” means the Spatial Data Infrastructure Act, 2003 (Act No. 54 of 2003); and

“**the Committee**” means the Committee for Spatial Information contemplated by section 5 of the Act.

## 2. Calling for nominations

(1) Nominations of persons for the appointment of members of the Committee as contemplated by section 5 of the Act, must be called for by –

- (a) publishing a notice in the *Gazette* and at least one national newspaper and any other appropriate media, indicating the categories of members to constitute the Committee, the number of members to be appointed in each category and the persons or bodies entitled to nominate persons in the specified categories;
- (b) inviting interested persons, associations, institutions and organisations to submit nominations; and
- (c) taking any other steps the Minister deems necessary.

(2) Nominations must be called for at least 30 days before the selection process to appoint members in terms of section 5 of the Act, takes places.

## 3. Commencement of regulation

**This regulation** comes into operation on the date of publication thereof in the *Gazette*.
