The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 44(2) of the Independent Broadcasting Authority Act, No 153 of 1993, as amended, that it has received an application from Zibonele Community Radio (Radio Zibonele) for the renewal of its community sound broadcasting licence in terms of section 44(1). 4. Persons who lodge representations in terms hereof, **must simultaneously** indicate whether they also require an opportunity to make oral representations to the Authority.

Persons who lodge representations in terms hereof, shall at the **time of** lodgement furnish proof to the satisfaction of the Authority that a copy of **the** representation has been delivered by hand to Mr Mzamo Ngomana, Station Manager, Radio Zibonele, Ngcwalazi Street, Cetric Building, Litha Park, Khayelitsha, or sent by registered post to P. O. Box **294** Khayelitsha **7784**, or faxed to **(021) 361 5194**.
6. Radio Zibonele shall be entitled to respond in **writing** to written representations made by interested persons on the proposed renewal, and such **written** response must be **lodged** with the Authority within sixty (60) days of the date of publication of this notice in the Government Gazette. Radio Zibonele **must**, at the time of lodging such written response, furnish proof to the **Authority's** satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
