1. The Independent Communications Authority of South Africa ("the **Authority**") **hereby gives notice**, in terms of section 52(2) (a) of the Independent Broadcasting Authority Act, Act No 153 of 1993 ("the **IBA Act**") as amended, that it has received an application from Orange Farm Community Radio for the amendment of Orange Farm Community Radio's **broadcasting licence** in terms of section 52(1) (c) of the Act, as per **the schedule below**.
2. This application is available for inspection by **any interested parties** during the Authority's **normal office hours**.
3. **Interested persons are** hereby invited to make written representations on the proposed amendment to the Authority by 16 June **2006**.
4. Orange Farm Community Radio shall **be entitled** to respond in writing to the written representations made by interested persons on **the proposed amendment**, and any such **written response must** be submitted **to the Authority within sixty (60) days of the date of publication of this notice** in the **Government Gazette**. Orange Farm Community Radio must, at the time of **submitting its written response**, furnish **proof to the Authority's satisfaction** that **it** has delivered a **copy of the response** by hand, or has sent a copy of the response by registered mail or by facsimile, to the relevant persons having made written representations.
