REGULATIONS RELATING TO THE REGISTRATION OF FERTILIZERS, FARM FEEDS, AGRICULTURAL REMEDIES, STOCK REMEDIES, \$TERILISING PLANTS AND PEST CONTROL OPERATORS, APPEALS AND IMPORTS: PROPOSED AMENDMENT

I, Lulama Xingwana, acting under section 23 of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947 (Act No. 36 of 1947), has made the regulations set out in the Schedule.
