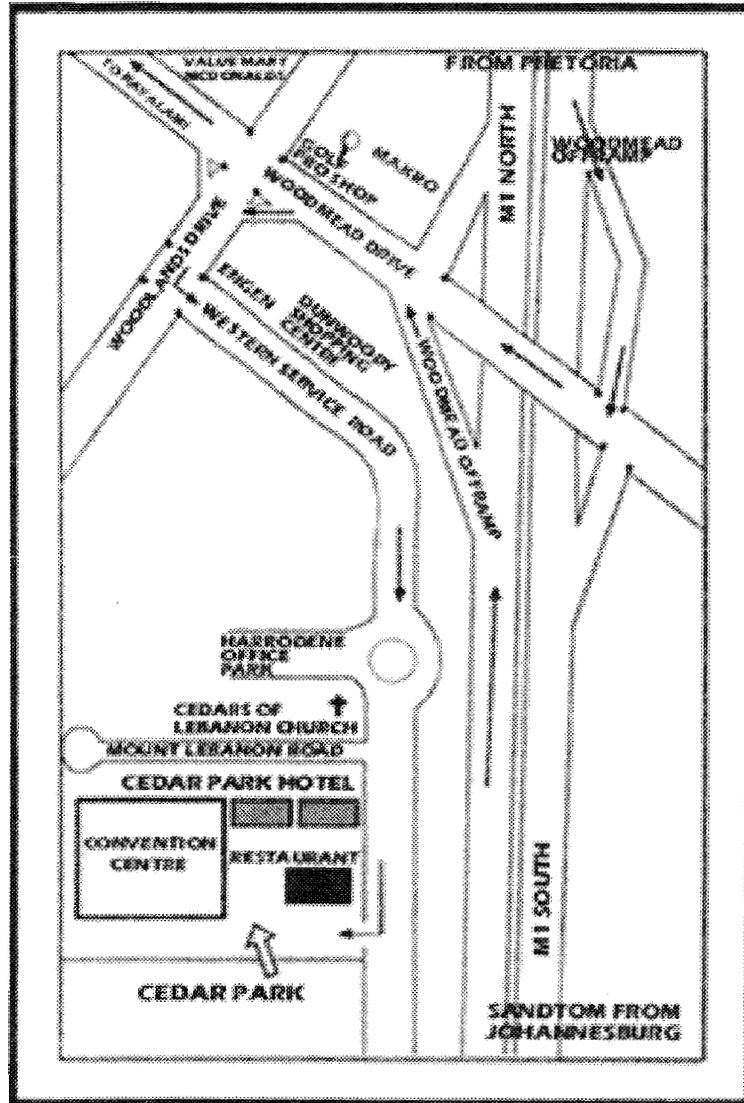

### From Pretoria

- ✘ Take **M1** Direction **South** to **Johannesburg**
- ✘ Take **Woodmead** off Ramp
- ✘ Turn right into **R55** towards **Kyalami**
- ✘ Turn **left** at first set of traffic lights into **Woodlands Drive**
- ✘ Turn **left** at first set of traffic lights into **Western Service Road**
- ✘ 1.2 km/s along Western Service Road. The hotel is on the right hand side entering directly off the main road.
