## NURSING ACT, 1978 (ACT NO. 50 OF 1978)

#### REGULATIONS REGARDING REGISTERS: AMENDMENT

The Minister of Health has in terms of section 45(1) of the Nursing Act, 1978 (Act No. 50 of 1978), on the recommendation of the South African Nursing Council, made the regulations in the Schedule.

### **SCHEDULE**

#### **Definitions**

 In this Schedule "the Regulations" means the regulations published under Government Notice No. R. 3589 of 24 October 1969, as amended by Government Notices Nos. R. 1201 of 7 July 1972, R. 772 of 11 May 1973, R. 1854 of 8 October 1976, R. 2206 of 31 October 1980, R. 814 of 30 April 1982, R. 1419 of 1 July 1983, R. 1905 of 23 September 1988, R. 2194 of 6 September 1991, R. 1322 of 23 July 1993, R. 1128 of 28 July 1995, R. 1132 of 23 September 1999, R. 1305 of 5 December 2001, R. 149 of 24 January 2003, R. 859 of 13 June 2003 and R. 702 of 22 July 2005.

# Amendment of regulation 2 of the Regulations

- 2. Regulation 2 of the Regulations is hereby amended by -
  - (a) the substitution in subregulation (2)(a)(vi) for the expression "three hundred rand (R300) in" of the expression "three hundred and twenty-eight rand and ninety-five cents (R328,95), excluding VAT, in";
  - (b) the substitution in subregulation (2)(b)(i) for the expression "fifty rand (R50) in" of the expression "fifty-five rand and twenty-six cents (R55,26), excluding VAT, in"; and
  - (c) the substitution in subregulation (2)(b)(ii) for the expression "two hundred rand (R200) in" of the expression "two hundred and nineteen rand and thirty cents (R219,30), excluding VAT, in".

## Amendment of regulation 3 of the Regulations

- 3. Regulation 3 of the Regulations is hereby amended by -
  - (a) the substitution in subregulation (2)(a)(v) for the expression "three hundred rand (R300) in" of the expression "three hundred and twentyeight rand and ninety-five cents (R328,95), excluding VAT, in";
  - (b) the substitution in subregulation (2)(b)(i) for the expression "one hundred rand (R100) in" of the expression "one hundred and nine rand and sixty-five cents (R109,65), excluding VAT, in"; and
  - (c) the substitution in subregulation (2)(b)(ii) for the expression "two hundred rand (R200) in" of the expression "two hundred and nineteen rand and thirty cents (R219,30), excluding VAT, in".

## Amendment of regulation 4 of the Regulations

4. Regulation 4 of the Regulations is hereby amended by the substitution in subregulation (1) for the expression "one hundred and sixty-nine rand and thirty cents (R169,30)" of the expression "one hundred and eighty-six rand and eighty-four cents (R186,84)".

#### Amendment of regulation 6 of the Regulations

- 5. Regulation 6 of the Regulations is hereby amended by -
  - (a) the substitution in subregulation (1)(a) for the expression "fifty-two rand and sixty-three cents (R52,63)" of the expression "fifty-eight rand and seventy-seven cents (R58,77)"; and
  - (b) the substitution in subregulation (1)(b) two hundred and seventy-six rand and thirty-two cents (R276,32)" of the expression "three hundred and four rand and thirty-nine cents (R304,39)" for the expression ".

## **Commencement of regulations**

6. These regulations shall come into operation on the date of publication in the *Gazette*.

# **Transitional arrangements**

- 7. Regulation 4 of these regulations will not apply to annual fees in respect of the -
  - (a) 2006 calendar year; and
  - (b) 2007 calendar year if the annual fee was paid before the date of publication of these regulations.
