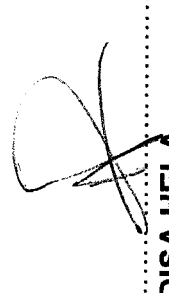
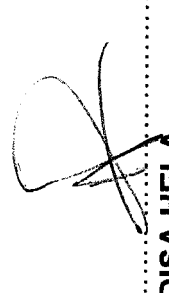


DEPARTMENT OF HEALTH No. 95 9 February 2007 EXCLUSION OF CERTAIN MEDICINES FROM THE SCOPE OF CERTAIN PROVISIONS OF THE MEDICINES AND RELATED SUBSTANCES ACT, 1965 (ACT NO. 101 OF 1965) I, Mandisa Hela, Registrar of Medicines, acting by virtue of a delegation in terms of section 34A of the Medicines and Related Substances Act, 1965 (Act 101 of 1965), hereby exclude in terms of Section 36 of Act 101 of 1965, on the unanimous recommendation of the members present at a meeting of the Medicine Control Council held on 1 December 2006 the medicines listed in the schedule hereto from the operation of the therein listed provisions of the regulations promulgated by Government Notice No. R.510 of 10 April 2003.
