- 2. The amendment is sought to enable the applicant to expand its coverage as follows:
 - 2.1 SABC 1's coverage in the Eastern Cape, Kwazulu-Natal, Limpopo, Northwest and Mpumalanga provinces,
 - 2.2 SABC 2's coverage in the Eastern Cape, Limpopo and Mpumalanga provinces, and
 - 2.3 SABC 3's coverage in the Limpopo, Mpumalanga, North West **and** Eastern Cape provinces.
- 3. The effective date of the amendment would be the date on which the Authority's decision on the application would be published.
- 4. The applications, relevant schedules and any representations received pursuant thereto would be made available and open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
- 5.
