### NOTICE 470 OF 2007



### INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA (ICASA)

#### THE INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA HEREBY GIVES NOTICE OF PUBLIC HEARINGS TO BE HELD WITH REGARD TO WHOLESALE CALL TERMINATION.

ICASA published a discussion document in Government Gazette Notice 78 of 29 January 2007.

The objective of the discussion document was to elicit responses from the public and interested parties on the wholesale call termination market definition and to identify the presence or absence of significant market power (SMP) in the call termination market, and to propose remedies to address SMP should it be found to be present. The identification of such relevant markets will serve to delineate the boundaries within which any effective and meaningful analysis pertaining to the competitive dynamics of the relevant markets may be ascertained.

Written representations were received on 2 April 2007 and are available on the Authority's website and library.
