PROMOTION OF ACCESS TO INFORMATION ACT, 2000 REGULATIONS REGARDING THE PROMOTION OF ACCESS TO INFORMATION AMENDMENT OF REGULATIONS

SCHEDULE

Definitions

1. In these regulations 'Yhe Regulations' means the Regulations published by Government Notice No. R. 187 of 15 February 2002, as amended by Government Notices Nos. R. 1244 of 5 September 2003 and R. 990 of 13 October 2006.

Insertion of Regulation 5A in the Regulations

2. The following regulation is hereby inserted after regulation 5 of the Regulations:

"Voluntary disclosure and automatic availability of certain records: public body

- 5A. A submission by the information officer of a public body of a description of -
 - (a) the categories of records of the body that are automatically available without a person having to request access in terms of the Act; and
- (b) how to obtain access to such records, as contemplated in section 15 of the Act, must correspond substantially with Form D of Annexure B.".

Insertion of Regulation 9A in the Regulations

3. The following regulation is hereby inserted after regulation 9 of the Regulations:

"Voluntary disclosure and automatic availability of certain records: private body

- 9A. A submission by the head of a private body of a description of -
 - (a) the categories of records of the body that are automatically available without a person having to request access in terms of the Act; and
- (b) how to obtain access *to* such records, as contemplated in section 52 of the Act, must correspond substantially with Form **E** of Annexure B.".
