PROPOSED PROHIBITION ON THE USE OF CERTAIN WORDS AND EMBLEMS FOR FIFA WORLD CUP 2007

I, Mandisi Mpahlwa, Minister of Trade and Industry, in pursuance of the requirements of Section 13 of the Merchandise Marks Act 1941 (Act 17 of 1941), hereby give notice that the Federation Internationale de Football Association (FIFA), has conveyed a request for a prohibition, in terms of Section 15(1)(b) of the said Act, on the use of certain words and emblems as depicted in the attached documents, Annexure A, B1, B2, B3, C1 and C2 in connection with any trade, business, profession, occupation or event, or in connection with a trade mark, mark or trade description applied to goods other than the use thereof by FIFA or its mandatories.

Please note that in deciding on this matter, I will also consider principles contained in the Trade Marks Act, 1993 (Act No. 194 of 1993), dealing with issues considered before trade marks are granted or not granted.
