



STANDARDS ACT, 1993

**REGULATIONS RELATING TO THE PAYMENT OF LEVY AND THE ISSUE OF SALES
PERMITS IN REGARD TO COMPULSORY SPECIFICATION: AMENDMENT**

It is made known under section 37 of the Standards Act, 1993 (Act No. 29 of 1993), that the Minister of Trade and Industry, hereby with effect from date of publication in the Government Gazette, amends Schedule 2 of the Regulations published by Government Notice No. R999 of 3 May 1985 by the deletion of the existing tariffs for food products, and the substitution thereof with the tariffs set out in the attached Schedule.
