AGRICULTURAL PRODUCT STANDARDS ACT, 1990 (ACT NO. 119 OF 1990)

AMENDMENT OF STANDARDS AND REQUIREMENTS REGARDING CONTROL OF THE EXPORT OF LESSER KNOWN TYPES OF MAIZE AND REPEAL OF STANDARDS AND REQUIREMENTS REGARDING CONTROL OF THE EXPORT OF POPCORN

I, Ebenhaezer Rademeyer, appointed as Executive Officer in terms of section 2(1) of the Agricultural Product Standards Act, 1990 (Act No. 119 of 1990), hereby give notice under section 4(3) (c) of the said Act, that –

- (a) the standards and requirements regarding control of the export of Lesser Known Types of Maize as stipulated in Government Notice No. R 1983 of 23 August 1991 and promulgated in Government Notice No. 35 of 14 January 1994 ;
- (b) the standards and requirements regarding control of popcorn as stipulated in Government Notice No. R 1983 of August 1991 and promulgated in Government Notice No. R 950 of 24 June 2005 is hereby repealed and replaced by the standards and requirements of lesser known types of maize; and
- (c) the standards and requirements mentioned in paragraph (a) –
 - (i) shall be available for inspection at the office of the Executive Officer: Agricultural Product Standards, Harvest house, 30 Hamilton Street, Arcadia, Pretoria;
