AGRICULTURAL PRODUCT STANDARDS ACT, 1990 (ACT NO. 119 OF 1990)

AMENDMENTS OF THE STANDARDS AND REQUIREMENTS REGARDING CONTROL OF THE EXPORT OF LEGUMINOUS SEEDS AND REPEAL OF THE THE STANDARDS AND REQUIREMENTS REGARDING CONTROL OF THE EXPORT OF SOYA BEANS

I, Ebenhaezer Rademeyer, appointed as Executive Officer in terms of section 2(1) of the Agricultural Product Standards, 1990 (Act No. 119 of 1990), hereby give notice under section 4(3)(c) of the said Act, that-

- (a) The standards and requirements regarding control of the export of Leguminous seeds stipulated by Government Notice No. R. 1983 of 23 August 1991, promulgated by Government Notice No. 521 of 23 June 1995 and amended by Government Notice No. 1081 of 18 August 2006 are hereby amended; and
- (b) the standards and requirements regarding control of the export of soya beans as stipulated by Government Notice No. 1983 of 23 August 1991, promulgated by Government Notice No. 949 of 24 June 2005 is hereby repealed.
- (c) The standard and requirements mentioned in paragraph (a)-
 - (i) shall be available for inspection at the office of the Executive Officer: Agricultural Product Standards, Harvest House Building, 30 Hamilton Street, Arcadia, Pretoria
