#### SCHEDULE 1

#### PROPOSED AMENDMENTS OF REGULATIONS 145.02.7, 145.03.7/145.04.7/145.05.7/145.06.7/145.07.7 AND 145.08.7 OF PART 145 OF THE REGULATIONS

**1.1** It is proposed to amend regulation 145.02.7 of the Regulations by the substitution for the said regulations of the following regulation:

## **ISSUING OF APPROVAL**

145.02.7 (1) The Commissioner shall issue an aircraft maintenance organisation approval if the applicant complies with the requirements of regulation 145.02.1 to 145.02.5 inclusive.

(2) The approval with the relevant rating shall be issued on the appropriate form and Operation Specifications as prescribed in document SA-CATS-AMO .

### **1.3 CURRENT REGULATION**

#### **ISSUING OF APPROVAL**

145.02.7 (1) The Commissioner shall issue an aircraft maintenance organisation approval with a Category A rating, if the applicant complies with the requirements prescribed in Regulations 145.02.1 to 145.02.5 inclusive.

(2) The Commissioner shall issue the approval on the appropriate form as prescribed in Document SA-CATS-AMO.
