REMUNERATION OF MEMBERS

The remuneration of the members of the Board will be in accordance with the provisions of section 6(10) of the Act.

DISQUALIFICATIONS

In line with the Protocol on Corporate Governance in the Public Sector, section 218 of the Companies Act, and the provisions of the Act, the following people are disqualified from being nominated and appointed as members of the Board:

- An unrehabilitated insolvent:
- A person under curatorship;
- · A person declared to be of unsound mind by a Court of law;
- A person who was convicted, in terms of the Companies Act, for a fraudulent offence and sentenced to imprisonment without the option of a fine for a period of not less than 12 months;
- · A person with a criminal record; or
- Misconduct requiring or justifying removal from the office of trust.
