### **APPLICATION FOR THE RENEWAL OF A FOUR YEAR COMMUNITY SOUND BROADCASTING LICENCE:**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 5(7) read with section 95(2) of the Electronic Communications Act, No. 36 of 2005, that it has received an application from Naledi Community Radio Station for the renewal its four year community sound broadcasting licence.
2. The renewal is sought to continue broadcasting as a community radio station in Senekal and surrounding areas.
3. The application is available and open for inspection by interested persons in the Authority's library during the Authority's normal office hours.
4. Interested persons are invited to lodge written representations in relation to the application by no later than 13 February 2008. Representations must be directed to Mr Fred Falken at the Licensing Unit, Broadcasting Division, Independent Communications Authority of South Africa at Block D, Pinmill Farm, 164 Katherine Street, Sandton, Johannesburg or Private Bag x 10002 Sandton, 2146 or by fax no. 5. Persons who lodge representations in terms hereof, must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority if a hearing were to be held.

6. Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Ms Mamoleleki Station manager at 1836 Johnstone Street Matwabeng Senekal 9600 or sent by registered post to PO Box 580 Senekal 9600 or faxed to ( 058) 481 5182.
7. Naledi Community Radio Station shall be entitled to respond in writing to written representations made by interested persons on the proposed amendment, and such written response must be lodged with the Authority within sixty (14) days of the date of publication of this notice in the *Government Gazette*. Naledi Community Radio Station must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
