The arms of Ethel Ivy Middleton (Nee Lawson-Fitch), as published in Government Notice No. 1536 of 9 September 1994 and registered under Government Notice No. 2234 of 23 December 1994, have been matriculated with, for difference, at fess point a crescent counterchanged, for her second grand-son Hew David Waldron de Bowen as heraldic heir.

The arms of Alice Florence Rose de Bowen (Nee Waldron), as published in Government Notice No. 141 of 30 January 1981 and registered under Government Notice No. 1028 of 15 May 1981 and matriculated to her son Alfred William de Bowen under Government Notice No. 2054 of 13 December 1996, have been matriculated with, for difference, at fess point, in the place of the Maltese cross, a crescent Or, for her second grand-son Hew David Waldron de Bowen as heraldic heir.

The arms of Marylone Maghanoy de Bowen, as published in Government Notice No. 1313 of 16 August 1996 and registered under Government Notice No. 366 of 26 March 1999, have been matriculated, undifferenced, for her brother, Mildexe Macias Maghanoy as heraldic heir.
