

NOTICE 932 OF 2008**DEPARTMENT OF LAND AFFAIRS****CALL FOR NOMINATION OF PERSONS TO SERVE ON THE APPEAL BOARD****PLANNING PROFESSION ACT, 2002 (ACT NO. 36 OF 2002)**

Under sections 24(6 and 4(3) of the Planning Profession Act, 2002 (Act No. 36 of 2002) ("the Act"), I, Lulama Xingwana, Minister for Agriculture and Land Affairs, hereby invite interested persons, voluntary associations and organisations to submit nominations of suitably qualified persons who are prepared to serve as member(s) of the Appeal Board ("the Board") in terms of the Act.

Categories of persons to constitute the Board are:

- **Three** persons who have been practicing or teaching planning for a period of not less than five years; and
- **Two** members of the public of whom at least one person is qualified in law and has at least five years' experience in the legal profession.

Persons nominated must not be disqualified in terms of sections 24(7) and 5 of the Act. In appointing members of the Council, the Minister will take into account, among other things, the principles transparency and representivity.

Board members will hold office for a period of four years from the date the appointment takes effect to be published in the Gazette.

A nomination should be accompanied by an **acceptance** letter and **curriculum vitae** and should mention category in which the person is nominated.
