

**BOARD NOTICE 95 OF 2008****DEFINING OF THE PRODUCTION AREA: THEEWATER**

The Wine and Spirit Board, acting under section 6 of the Wine of Origin Scheme published by Government Notice No. R. 1434 of 29 June 1990 hereby –

defines the area specified in the Schedule as a production area (ward) under the name Theewater.

**SCHEDULE****DEFINING OF PRODUCTION AREA: THEEWATER**

That area situate within the following boundaries:

Start at the point where the R45-road from Franschhoek, in the vicinity of the Draailberg Brigde, joins the 321-road; thence north-east with the northern boundary of farm 459 to the north-eastern boundary of farm 459 to the north-eastern beacon thereof; thence north-east with an imaginary straight line to the southern beacon of Vondeling 23; thence north-east with the south-eastern boundaries of said Vondeling 23 and Nootgedacht 9 to the south-eastern beacon thereof; thence north-east with the generally north-western boundary of Radyn 24 to the northern beacon thereof; thence north with the north-western boundaries of farms 581 and 582 to a point approximately 780 metres north of the south-western beacon of said farm 582; thence east with an imaginary straight line to a point, approximately 1 130 metres north of the south-eastern beacon of said farm 582 where it joins the south-eastern beacon of said farm 582; thence south with said south-eastern boundary to the southern beacon thereof; thence further south with the eastern boundary of Radyn 24 to a point

where the 500 metre contour intersects said boundary; thence generally south with said contour to a point where it intersects the eastern boundary of Theewaterskloof 68; thence further south with the eastern boundary of said Theewaterskloof 68 to a point where the Riviersonderend River intersects said boundary; thence generally west with said Riviersonderend River to a point where it intersects the southern boundary of Dwarstrek 119; thence south-west with the southern boundary of said Dwarstrek 119 to the southern beacon thereof; thence south-west with an imaginary straight line to the eastern beacon of Welgemoed 113; thence first south-west and then north-west with the south-eastern and south-western boundaries of said Welgemoed 113 to the south-western beacon thereof; thence west with an imaginary straight line to the southern beacon of farm 104; thence north-west with the south-western boundaries of farm 105, Botrivier 106 and Fortuin 83 to the eastern beacon of farm 813; thence south-west with the eastern boundaries of said farm 813 and farm 799 to the south-eastern beacon thereof; thence west with the generally southern boundaries of said farm 799, farms 86 and 814 to the south-western beacon thereof; thence generally north with the general western boundaries of said farm 814, farms 88, 90, 86, 457, 801 and 21 to the north-western beacon thereof; thence south-east with the northern boundary of said farm 21 to the north-eastern beacon thereof; thence generally north with the western boundary of farm 20 to the northern beacon thereof; thence south-east with the north-eastern boundary of said farm 20 to where it joins the Theewaterskloof Dam; thence generally south-east with said Theewaterskloof Dam to a point where the R45-road from Franschhoek, in the vicinity of the Draaiberg Bridge joins the 321-road, the point of beginning mentioned above.
