**Guilty** of contravention of Rule 2(b),(d),(e) and 2(f) of the Rules of Conduct for Registered Persons promulgated under Board Notice 107 of 1997 Government Gazette number 18454 of 28 November 1997.

1. Payment of a fine towards the council, in terms of the provisions of section 32(3)(a)(ii) in the amount of R2 500 (Two Thousand Five hundred Rand) per charge, thus a total of R 10 000 (Ten Thousand Rand)
