PARTY ELECTION BROADCASTS (PEBs) AND POLITICAL ADVERTISEMENTS (PAs) DURING ELECTION PERIOD

I, Paris Mashile, Chairperson of the Independent Communications Authority of South Africa ("the Authority") hereby publish the schedule to monitor Party Election Broadcasts (PEBs) and Political Advertisements (PAs) during the election period in terms of Sections 56, 57, 58 and 59 of the Electronic Communications Act No. 36 of 2005 ("the ECA").

The Independent Communications Authority of South Africa ("the Authority") is empowered in terms of Sections 56, 57, 58 and 59 of the Electronic Communications Act No. 36 of 2005 ("the ECA") to monitor Party Election Broadcasts (PEBs) and Political Advertisements (PAs) during election period.

The Authority has, under Section 57(2) of the ECA determined the time to be made available to political parties for the broadcast of PEBs, including the duration and scheduling PEBs.
