**CUSTOMS AND EXCISE ACT, 1964.
AMENDMENT OF SCHEDULE NO. 2 (NO. 2/313)**

Under section 56 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 2 to the said Act is hereby amended to the extent set out in the Schedule hereto:

1. Codes 01.06, 02.06, 03.06 and 04.06 to tariff heading 3904.10, is hereby withdrawn **with retrospective effect from 18 October 2007**;
2. Codes 01.06, 02.06, 03.06 and 05.06 to tariff heading 7615.19, is hereby withdrawn **with retrospective effect from 14 February 2008**; and
3. Codes 02.06 and 05.06 to tariff heading 8201.30, is hereby withdrawn **with retrospective effect from 31 January 2008**.
