**APPLICATION FOR REGISTRATION OF HERALDIC REPRESENTATIONS AND  
OBJECTIONS THERETO**

**SECTIONS 7, 7A AND 7B OF THE HERALDRY ACT, 1962 (ACT NO. 18 OF 1962)**

The undermentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for the registration of their heraldic representations. Anyone wishing to object to the registration of these heraldic representations on the grounds that such registrations will encroach upon rights to which he or she is legally entitled should do so within one month of the date of publication of this notice upon a form obtainable from the State Herald, Private Bag X236, Pretoria, 0001.

1. APPLICANT: Labuschagne Family Association (H4/3/1/4080)

ARMS: Per pale, dexter per fess wavy Azure and Gules, over the partition a bar wavy Argent, between in chief a Huguenot cross Argent and in base a wagon wheel Or; sinister Argent, a baobab proper; a chief Or, filleted Sable.

2. APPLICANT: Aganang Local Municipality (H4/3/2/830)

ARMS: Per fess Azure, and Or, on a fess Argent, a trimount abaisse Vert, ensigned in pale of a maize cob, issuant from its base bendwise and bendwise sinister two shovels, all proper; between in chief, a demi-sun issuant Or, charged with a demi-torteau, and in base upon a mound Vert a Marulatree proper. The shield is ensigned of a mural crown Or, charged with a bar Or, there-upon a chain of circular links Sable.

MOTTO: MMOGO RE TLA KGONA

3. APPLICANT: The National Prosecuting Authority of South Africa: Witness Protection Unit (H4/3/3/112/1)

BADGE: A Fish Eagle above its nest with wings displayed proper.

4. APPLICANT: John Gordon Crowley (H4/3/4/792)

STANDARD: In the hoist the arms of John Gordon Crowley, namely Sable, a lion's face, and in chief, three eagles with wings displayed, all Or; and in the fly: Sable, divided into three compartments by two transverse bands Or, which together bear the motto FILII DESERTAE in letters Sable, in the 1<sup>st</sup> compartment a sun Or, charged with a mill rind Gules; in the 2<sup>nd</sup> compartment, his crest namely, a wolf rampant Sable, holding in his dexter paw a pine branch proper, all fimbriated Or, and in the 3<sup>rd</sup> compartment, a sun Or, charged with a mill rind Sable; fringed alternately Sable and Or.

5. APPLICANT: Paul Eric Ross (H4/3/4/891)

ARMS: Per chevron Gules and Vert, over the partition, a fillet chevron, between in chief dexter a bear, his sinister foot couped at midpoint, and sinister a lion, both combatant, and in base a salmon counter-naiant, all Argent.

CREST: A stag's head caboshed Argent, between his antlers a laurel wreath Vert.

WREATH AND MANTLING: Gules and Argent

MOTTO: MATHAN REANNAGACH LE CASAN GU LETH

6. APPLICANT: Robert Reeves Turbyfill, Jr. (H4/3/4/904)

ARMS: Argent, two guns in saltire Sable, debriused by a sword erect proper, hilted Or, surmounted by a cross paty notched and fimbriated Azure, thereupon a plate Argent, charged, within an annulet Azure, with a Jerusalem cross Gules.

CREST: In front of a cross paty notched and fimbriated Argent, with on each tip a plate, charged with an annulet Azure, fimbriated Argent, two George Washington swords in saltire proper.

WREATH AND MANTLING: Azure and Argent.

MOTTO: E TENEBRIS LUX

7. APPLICANT: Johannes Venter Family Association (H4/3/1/4096)

ARMS: Per chevron Gules and Sable, over the partition a pall inverted Or, between in chief dexter a Huguenot cross Argent, sinister a lion rampant Or and in base a protea flower Or, seeded Argent; a chief Argent.

8. APPLICANT: Mark Paul Lindley-Highfield of Ballumbie Castle (H4/3/4/914)

ARMS: Per fess Purpure and Vert, a fess chequy Sable and Argent, between in chief a castle with two towers Argent, masoned Sable, with windows and port Azure, and in base a rose Argent, barbed Sable, seeded Or.

CREST: Two black swans respectant proper, their necks and chests forming the shape of a heart; that to dexter wearing a John Knox cap proper and that to sinister wearing a chapeau Gules doubled Ermine.

WREATH AND MANTLING: Purpure, Argent and Vert.

MOTTO: DUMMODO UNA SIMUS CETERA BENE EVENIENT

9. APPLICANT: Rory Rhydal Cliff (H4/3/4/901)

ARMS: Per pale wavy Gules and Or, dexter three lions passant gardant in pale Or, armed and langued Azure, sinister an oak tree branch leafed and with two acorns proper; on a chief Sable an leopard passant gardant proper, armed and langued Gules.

CREST: Issuant from a crest coronet Or, a mount Gules, statant there-upon an antelope Gules, armed and unguled Or, gorged about the neck of a collar compony Gules and Argent the latter each charged with a Coeur Gules.

WREATH AND MANTLING: Gules and Or.

MOTTO: FORTITUDO ET PERTINACIA

## 10. APPLICANT: Monica Aileen Preller-Cliff (H4/3/4/902)

ARMS: Per pale wavy Or and Sable, dexter, issuant from the partition an eagle displayed Sable, clasping in its dexter claw a quill pen Argent, the shaft and nib Or, sinister within a treasure flory three lizards heads erased in pale, all Or.

CREST: Issuant from a crest coronet Or, an elk head and neck, attired with ten tynes proper.

WREATH AND MANTLING: Sable and Or.

MOTTO: DE KLEINE ANGST VOR VERÄNDERUNG
