


BOARD NOTICE 86 OF 2009**FINANCIAL SERVICES BOARD****PENSION FUNDS ACT, 1956 (ACT NO. 24 OF 1956)****CANCELLATION OF REGISTRATION IN TERMS OF SECTION 28(15)
OF THE PENSION FUNDS ACT, 1956**

In terms of section 28(15) of the Pension Funds Act, 1956, notification is hereby given of the Registrar's intention to cancel the registration of the pension funds as listed in **Annexure A** and participating employers of umbrella funds as listed in **Annexure B** to this Notice.

According to the records of the Registrar:

- the pension funds and participating employers so listed, terminated through liquidation and all benefits have been paid to members and/or beneficiaries; and
- that the liquidator failed to submit final accounts and to apply to the Registrar for the cancellation of the relevant registration.

Unless the Registrar is informed and is provided with sufficient proof that a fund or participating employer has not terminated, the registration of the abovementioned funds or participating employers will be cancelled 30 days after the publication of this Notice.
