# APPLICATION FOR REGISTRATION OF HERALDIC REPRESENTATIONS AND OBJECTIONS THERETO

SECTIONS 7, 7A AND 7B OF THE HERALDRY ACT, 1962 (ACT NO. 18 OF 1962)

The undermentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for the registration of their heraldic representations. Anyone wishing to object to the registration of these heraldic representations on the grounds that such registrations will encroach upon rights to which he or she is legally entitled should do so within one month of the date of publication of this notice upon a form obtainable from the State Herald, Private Bag X236, Pretoria, 0001.

- 1. APPLICANT: West Coast District Municipality (H4/3/2/521)
- BADGE: On a background Argent a demi-cogwheel Azure, placed in bend sinister, in the centre a plate Argent, edged of the second, there upon a roundel per saltire Azure, Or, Vert and Gules, charged with in chief, a seagull, dexter an ear of wheat, sinister a bunch of grapes and in base a daisy flower all Argent.
- APPLICANT: The South African Police Service: Community Police Forum (H4/3/3/10/21)

BADGE: Two greeting hands, the arms cuffed and couped vertically in relief Azure, there above a bezant, charged with the aloe of the South African Police Service.

3. APPLICANT: Nelson Mandela Bay Metropolitan Police Service (H4/3/2/833)
BADGE: On a shield Or, in chief, a demi-sun Tenné issuant from a barrulet embowed, the edges pointed Azure, over all a human figure with outstretched arms Murray, in the flanks

two elephant tusks Argent, edged Azure, and in base a seven-pointed faceted star Azure; on a bordure Azure an open laurel wreath between in chief two, an in base one sevenpointed faceted stars all Or. The whole within an annulet Azure there upon the words NELSON MANDELA METRO POLICE, in chief and in base 2010, separated on either side by two seven-pointed faceted stars all Or.

4. APPLICANT: Nelson Mandela Bay Metropolitan Police Service (H4/3/2/833)

FLAG: A rectangular blue flag, proportion 2: 3 charged with a bend sinister Or, and in the canton die shield of the Nelson Mandela Bay Police Service to wit: On a shield Or. in chief. a demi-sun Tenné issuant from a barrulet embowed, the edges pointed Azure, over all a human figure with outstretched arms Murray, in the flanks two elephant tusks Argent. edged Azure, and in base a seven-pointed faceted star Azure; on a bordure Azure an open laurel wreath between in chief two, an in base one seven-pointed faceted stars all Or.

5. APPLICANT: The South African Society of Occupational Health Nursing Practitioners (H4/3/1/4097)

BADGE: On a background Argent, a cogwheel charged with a cross couped, there upon another all in umbra, at fess point an antique oil lamp all Brunatré.

6. APPLICANT: Johannes Jacobus Roets (H4/3/4/880)

ARMS: Gules, three wagon wheels placed two and one and a tressure Or; on a bordure Azure, seven bezants.

CREST: On a rocky ground two outward issuant thorn twigs, flowered and leafed proper. surmounted of an open book Or, bound Sable.

WREATH AND MANTLING: Gules and Or and Azure and Or.

MOTTO: ROTSVAS

#### 7. APPLICANT: Angelo Anthony Sedacca (H4/3/4/898)

ARMS: Gules, on a chevron Azure, fimbriated Argent, twelve mullets Argent, between in chief an open book between dexter a tower, Argent and sinister a papal throne proper, in base a lion rampant ensigned of a kings coronet, brandishing in his dexter claw an academic mace all Or; a bordure Or.

CREST: Seated upon the horizontal arm of a scale of justice Or, a swan close Argent.

WREATH AND MANTLING: Gules and Or.

MOTTO: DÉFENDRE ET TRANSMETTRE LA LOI DIVINE

#### 8. APPLICANT: Baltazar Mora Jr. (H4/3/4/909)

ARMS: Per chevron Azure and Gules, on a chevron Argent, dexter an arrow and sinister a sword proper, between in chief dexter a mulberry tree proper fructed Purpure, sinister a wolf rampant Argent, and in base an equestrian conquistador Or.

CREST: In front of an anchor in bend sinister Sable, roped Or, two mullets in pale Azure, the one raised behind the other, statant there upon an eagle with wings displayed Or.

WREATH AND MANTLING: Azure and Argent and Gules and Argent.

MOTTO: CONCIPIO, CONFIDO, ET PERFICIO

#### 9. APPLICANT: Ronny Andersen (H4/3/4/911)

ARMS: Gules, issuant from a log in fess, three oak leaves Argent.

CREST: A pair of bulls' horns quarterly Gules and Argent, issuant from either side three oak leaves palewise, quarterly Argent and Gules.

WREATH AND MANTLING: Gules and Argent.

MOTTO: NEC CELERANS NEC CESSANS

#### 10. APPLICANT: Giuseppe Rizzani (H4/3/4/915)

ARMS: quarterly enhanced, I, Argent a pale Gules; II, Gules on a base Vert a fox passant Argent, ensigned of a mullet of six points Or; III, Azure on a base embowed Vert a hedgehog passant Argent; IV, Azure a mullet of six points Argent, there above three cypress trees proper; over all a bar gably inverted Argent.

#### 11. APPLICANT: Tiziano Corneo (H4/3/4/916)

ARMS: Per fess Argent and Sable, in chief, an Evergreen Dogwood tree *cornus alternifolia* (Italian: corniolo) proper fruited Gules, and in base three bends Argent.

#### 12. APPLICANT: Lucio Terzi (H4/3/4/918)

ARMS: Per pale Gules and Argent, a chevron and two devil's doors in chief counterchanged.

CREST: A demi-lion rampant Gules.

WREATH AND MANTLING: Gules and Argent.

#### MOTTO: RETRORSUM NON REDITUR

#### 13. APPLICANT: Dion Govender (H4/3/4/913)

ARMS: Quarterly, Azure and Argent: I and IV goutté d'eau; II a fleur-de-lys Azure; III a lotus Azure; over the partition a cross patonce quarterly Argent and Azure.

CREST: Upon a set of two doric pillarheads debruised of one pillarbase proper a phoenix Or, with wings Argent, and feathers Azure and Or, issuant from flames of fire Gules.

WREATH AND MANTLING: Azure and Argent.

MOTTO: DEI GRATIA

### 14. APPLICANT: Tsantsabane Local Municipality (H4/3/4/832)

ARMS: Per chevron inverted Sable and Or, in chief a lozenge Argent and in base issuant from a howitzer cannon proper a demi-sun Gules charged with a demi-annulet Argent; two flaunches Vert.

MOTTO: PLAKE YA MANYORO

15. APPLICANT: The South African Police Service: National Intervention Unit: Proficiency Badge (H4/3/3/10/22)

BADGE: Upon a scroll Argent, a lightning bolt in bend Gules, between two faceted compass roses Gules and Sable; behind the scroll two swords in saltire Argent, hilted and pommeled Or; the whole within an open laurel wreath Or and ensigned of a ribbon Or bearing the letters NIU Sable.

#### 16. APPLICANT: Pherere Lucas Mashigo (H4/3/4/907)

ARMS: Brunâtre, a barrulet wavy Argent, debruised of an increscent of the second, between in chief a lion's face between two elephant tusks, and in base upon a rocky outcrop a thorn tree all proper.

MOTTO: MSHATE WA BATAU
