SCHEDULE

DEFINING OF PRODUCTION AREA WALKER BAY

That portion of land situate within the following boundaries:

Start at the point where the western boundary of The Draay 563, just east of the township area of Kleinmond, meets the Atlantic Ocean; thence first north and then generally east with the western and northern boundaries of said The Draay 563 to the north-eastern beacon thereof; thence further east with an imaginary straight line to the south-western beacon of Lekker Water 545; thence further east with the southern boundary of said Lekker Water 545 to the north-western beacon Hermanus River 542; thence north-east with the north-western boundary of said Hermanus River 542 to the northern beacon thereof; thence generally north-east with the general western boundaries of farms 474, 781, 473, 469, 820 and Compagnies Drift 435 to a point where the N2-freeway intersects the western boundary of said Compagnies Drift 435; thence north-east with the north-western boundary of said Compagnies Drift 435 to the northern beacon thereof; thence further north-east with an imaginary straight line, which is an extension of the north-western boundary of said Compagnies Drift 435, to the northern beacon of farm 791; thence north-west with an imaginary straight line to

the south-western beacon of farm 867; thence north with the western boundaries of said farm 867 and farm 866, Krakeel Poort 274 and Goedvertrouw 264 to the northwestern beacon thereof; thence north-east for about 1925 metres with the northwestern boundary of said Goedvertrouw 264 to a point where an imaginary straight line, drawn from the junction of the secondary roads (south-east of the farm Kanaän) joins it; thence south-east with the secondary road to where it joins the R43-road; thence south-east with said R43-road to where it joins the N2-freeway; thence southwest with said N2-freeway to a point where it intersects the north-eastern boundary of farm 362; thence generally south with said boundary and the eastern boundary of Avontuur 429 to where it joins the north-western boundary of Heuwelkraal 843; thence south-west with said north-western boundary of Heuwelkraal 843 and an imaginary straight line, which is an extension of said boundary, to where it joins the south-eastern beacon of farm 880; thence south-west with the south-eastern boundary of said farm 880 to a point where the Swart River intersects said boundary; thence south-east with said Swart River to a point where it intersects the western boundary of farm 475; thence south with an imaginary straight line to the northern beacon of Paarde Poort 539; thence first west and then south-east with the northern and south-western boundaries of said Paarde Poort 539 and the western boundary of Berg Randt 538 to the north-western beacon of Hemel en Aarde 587; thence generally east with the northern boundary of said Hemel en Aarde 587 to the north-eastern beacon thereof; thence north-east with an imaginary straight line to the westernmost beacon of Langhuis 758; thence further north-east with an imaginary straight line to the southwestern beacon of Morgen Rood 759; thence first east and then generally south with the northern and general eastern boundaries of Langhuis 758 to a point, where the road from Onrus to Caledon intersects said boundary; thence west with said road to a point where the 260 metre contour intersects said road; thence generally south-west with said contour to a point where said contour intersects the road from Onrus to Caledon; thence south-west with said Onrus/Caledon road to a point where said road intersects the eastern boundary of farm 588; thence first south and then generally west with the eastern and general southern boundaries of said farm 588 to the northwestern beacon of farm 590; thence generally south-west with the general eastern boundaries of Hemel en Aarde 587 and Hemel en Aarde 585 to the south-western beacon of Geln Varloch 591; thence generally east with the general southern boundaries of said Geln Varloch 591, Vogel Gat 592, Belle Vue 631 and Morning Star 630 to the south-eastern beacon thereof; thence further east with an imaginary straight line to the south-western beacon of Klippies Berg 628; thence east with the general southern boundaries of said Klippies Berg 628, farms 627, 626 and 625 to the south-

eastern beacon of last-mentioned farm; thence south with the eastern boundaries of Klein Rivier Kloof 660 and farm 662 to where it joins the north-western beacon of Paardenbergs Rivier 663; thence south-east with an imaginary straight line to the south-western beacon of farm 731; thence further south-east with the south-western boundary of said Farm 731 to the southern beacon thereof; thence east with an imaginary straight line to trigonometric beacon 152, Tafelberg; thence south with the eastern boundary of farm 667 to the south-eastern beacon thereof; thence further south with an imaginary straight line, which is an extension of the south-eastern boundary of said farm 667, to where it joins the southern boundary of farm 668; thence first north-east and then south-east with the northern boundary of Sandies Glen 129 to the south-eastern beacon of said farm 668; thence south-west with an imaginary straight line, which is an extension of the south-eastern boundary of said farm 668, to where it joins the eastern beacon of Landmeterskop 681; thence generally south-west with the general southern boundaries said Landmeterskop 681, Farms 682 and 683, Goed Vertrouw 684, Farm 685 and Helderfontein 688 to the north-eastern beacon of Ben Nevis 694; thence generally south-west with the general south-eastern boundaries of said Ben Nevis 694, Wind Heuvel 696, Strands Kloof 702, Bosch Bok Randt 704 and Bergyliet 705 to the south-western beacon of said Bergyliet 705; thence southwest with the western boundaries of farm 710 and Fransche Kraal 708 to the northeastern beacon of Klipfontein 711; thence west with the northern boundary of said Klipfontein 711 to where said boundary meets the Atlantic Ocean; thence generally north and north-west with the coastline of the bay known as Walker Bay to the point where the western boundary of The Draay 563 meets the Atlantic Ocean, the point of beginning mentioned above.
