

BOARD NOTICE 64 OF 2010**DEFINING OF THE PRODUCTION AREA: FRANSCHHOEK/FRANSCHHOEK
VALLEY (AMENDMENT)**

The Wine and Spirit Board, acting under section 6 of the Wine of Origin Scheme published by Government Notice No. R. 1434 of 29 June 1990 hereby –

- (a) defines the area specified in the Schedule as a production area (district) under the name Franschhoek/Franschhoek Valley and
- (b) repeals herewith Board Notices No R. 1551 of 20 July 1984.

SCHEDULE**DEFINING OF PRODUCTION AREA FRANSCHHOEK/FRANSCHHOEK VALLEY**

That portion of land situate within the following boundaries:

Start at the point where the Wemmershoek River intersects the eastern boundary of the land known as Zachariashoek; thence in a south-easterly direction along an imaginary straight line which is drawn to connect said point and the south-western beacon of the land known as Eenzaamheid; thence in a south-westerly direction along the northwestern boundary of the land known as Purgatory Outspan 1135 to the western beacon thereof; thence in a westerly direction along an imaginary direct line which is drawn to connect the said beacon and beacon 916 (Skerpheuvel); thence in a west-north-westerly direction along an imaginary direct line which is drawn to connect the said beacon and the point where the Berg River crosses the southern boundary of the land known as Berg Riviers Hoek 1145; thence in a north-westerly direction along said Berg River to a point where it crosses the eastern boundary of farm 1269; thence generally south with the eastern boundaries of said

farm 1269, farms 1368 and 1159 to the south-easternmost beacon thereof; thence generally south-west with the southern boundaries of said farm 1159, farm 1368, Lormarins 1166, farms 1170, 1647 and 153 to the south-western beacon thereof; thence further south-west with an imaginary straight line, which are drawn from said beacon to a point where it joins the Banghoek River; thence north-west with said Banghoek River to a point where it joins the Dwars River; thence north-east with said Dwars River to a point where it intersects the north-eastern boundary of farm 1211; thence north-west with the north-eastern boundary of said farm 1211 to a point where the 310 Road intersects said boundary; thence north-east with said 310 Road to where it joins the R45 Road; thence north-west with said R45 Road to a point where it joins the farm road, to the left of the area known as Sawmill; thence north-west with said farm road to a point where it joins an imaginary straight line, which is an extension of said farm road to where it joins the Berg River; thence south-east with said Berg River to a point where said Berg River intersects the south-western beacon of farm 1006; thence north-east with the southern boundary of said farm 1006 to the north-eastern beacon of Weltevreden 1007; thence further north-east with an imaginary straight line, which is an extension of the northern boundary of said Weltevreden 1007 to the north-western beacon of farm 886; thence north-west with an imaginary straight line, which is an extension of the western boundary of said farm 886 to a point where the 301 Road intersects the northern boundary of said farm 1006; thence north-east with the northern boundary of said farm 1006 to the northern beacon thereof; thence east with an imaginary straight line to a point where the Wemmershoek River crosses the eastern boundary of the land known as Zachariashoek, the point of beginning mentioned above.
