

BOARD NOTICE 104 OF 2010**HEALTH PROFESSIONS COUNCIL OF SOUTH AFRICA****HEALTH PROFESSIONS ACT, 1974 (ACT NO.56 OF 1974)****RULES RELATING TO THE REGISTRATION BY MEDICAL TECHNOLOGISTS OF
ADDITIONAL QUALIFICATIONS**

The Health Professions Council of South Africa has, in terms of section 61A (1) (l), read with section 35 and section 61(5) of the Health Professions Act, 1974 (Act No.56 of 1974), made the rules in the schedule.

SCHEDULE

1. In these rules, "the Act" means the Health Professions Act, 1974 (Act No.56 of 1974), and the word or expression to which a meaning has been assigned in the Act has that meaning, and unless the context otherwise indicates.
2. The following qualifications held by Medical Technologists shall be registrable as additional qualifications under section 35 of the Act:-
