1. The objective of this determination is to introduce the determination of salaries of Deputy Directors of Public Prosecutions, Chief Prosecutors and Chief Special Investigators under sections 18(1) and 19c(1) of the National Prosecuting Authority act, 1998 as well as further amendments:

- 1.1 The extension of the scale of the standard Public Service salary band for SMS level 13 (Grade A) and level 14 (Grade B) to SMS members employed in terms of the NPA Act.
- 1.2 The entry level salary for NPA Act SMS members on level 13 be the 8th notch of level 13 (Grade A) and level 14 be the 5th notch of level 14 (Grade B). In future be appointed on those minimums.
- 1.3. The alignment of the pay progression to the notches of the Public Service SMS employees, which is a gap of 1.5%.
- 1.4. The pensionable income for NPA Act SMS members will remain at 63% as is the current position.
