SOUTH AFRICAN PASSPORTS AND TRAVEL DOCUMENTS ACT, 1994

SIXTEENTH AMENDMENT OF THE SOUTH AFRICAN PASSPORTS AND TRAVEL DOCUMENTS REGULATIONS, 1996

The Minister of Home Affairs has under section 4 of the South African Passports and Travel Documents Act, 1994 (Act No. 4 of 1994), made the regulations in the Schedule.

#### **SCHEDULE**

#### **Definition**

1. In this Schedule "the Regulations" means the Regulations made under section 4 of the South African Passports and Travel Documents Act, 1994 (Act No. 4 of 1994), published under Government Notice No. R. 784 of 10 May 1996, as amended by Government Notice Nos. R. 1027 of 21 June 1996, R. 580 of 11 April 1997, R. 1564 of 21 November 1997, R. 353 of 13 March 1998, R. 384 of 24 March 1999, R. 251 of 17 March 2000, R. 314 of 30 March 2001, R. 409 of 28 March 2002, R. 1495 of 2 December 2002, R. 476 of 31 March 2003, R. 430 of

30 March 2004, R. 319 of 1 April 2005, R. 473 of 19 May 2006, R. 68 of 28 January 2008, and R. 346 of 27 March 2009.

## Amendment of regulation 9 of the Regulations

- **2.** Regulation 9 of the Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:
  - "(2) Subregulations (2) and (3)(a) up to and including (f) and (i) up to and including (l) of regulation 3 shall with the necessary changes apply to the documents referred to in subregulation (1).".

## Amendment of regulation 11 of the Regulations

- 3. Regulation 11 of the Regulations is hereby amended by—
  - (a) the substitution for subregulation (3) of the following subregulation:
    - "(3) A crew member certificate shall be valid for 10 years from date of issue: Provided the person to whom it is issued remains a member of the crew on an international flight of the airline by whom he or she was employed when the certificate was issued."; and
  - (b) the insertion of the following subregulations after subregulation (3):
    - "(3A) If the holder of a crew member certificate ceases to be a member of the crew on an international flight of the airline by whom he or she was employed when the certificate was issued, he or she must immediately hand in the crew member certificate to the nearest Home Affairs Office for cancellation.
    - (3B) The old format of crew member certificates (booklets) shall be valid until 31 December 2010.".

## Substitution of regulation 16 of the Regulations

**4.** The following regulation is hereby substituted for regulation 16 of the Regulations:

## "Fees

- **16.**" (1) Subject to subregulations (2) and (3), the fees payable in respect of the issue of a South African passport or travel document under the Act shall be as follows:
  - (a) South African passport: 32 and 48 pages: R190-00 and R380-00 respectively: Provided that the fee payable for a new format South African passport (32 pages) that runs out of blank visa pages before the expiry date thereof shall be R145-00;
  - (b) child passport......R145-00;
  - (c) document for travel purposes.....R145-00;
  - (d) emergency passport......R70-00;
  - (e) temporary passport......R90-00; and
  - (f) crew member certificate......R350-00.
- (2) No fees shall be payable in respect of an official passport, an emergency passport or a temporary passport issued to a person referred to in regulation 2(3).
- (3) The fees payable in respect of the replacement of a lost, stolen or damaged South African passport, child passport, document for travel purposes, emergency passport, temporary passport or crew member certificate referred to in subregulation (1), shall be double the fee mentioned in that subregulation: Provided that in instances where the documents referred to was lost, stolen or damaged through no negligence on the part of the holder, only the fee mentioned in subregulation (1) shall be payable."

### **Short title**

5. These Regulations shall be called the Sixteenth Amendment of the South African Passports and Travel Documents Regulations, 1996.
