## DRAFT UNDER-SERVICED AREA DEFINITION REGULATIONS

#### AND

#### THE EXPLANATORY MEMORANDUM

- (1) The Independent Communications Authority of South Africa ("The Authority") hereby, in terms of section 4(4) read with section 88(2) of the Electronic Communications Act, 2005 (Act No 36 of 2005) ("the Act"), publishes the draft regulations in respect of the definition of Underserviced Areas and the Explanatory Memorandum as contained herein.

#### Schedule

#### 1. DEFINITIONS

In these Regulations, any word or expression has the meaning assigned to it in the Electronic Communications Act, 2005 (Act No 36 of 2005), unless otherwise specified -

"District municipality" has the meaning assigned to it in the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998);

"Local municipality" has the meaning assigned to it in the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998); and

"Underserviced Area" is any area within a local or district municipality in which:

- (i) no electronic communications network has been constructed; or
- (ii) an electronic communications network has been constructed, but where there is no, or limited coverage in inhabited parts of the area, or
- (iii) an electronic communications network has been constructed, but over which no, or limited electronic communications services or broadcasting services are being provided

as determined by the Authority from time to time.

#### 2. LIST OF UNDERSERVICED AREAS:

- (1) The list of underserviced areas with regard to Electronic Communications Services and Electronic Communications Network Services is located in "Annexure A" of these Regulations.
- (2) The list of underserviced areas with regard to Broadcasting Services is located in "Annexure B" of these regulations.

## 3. Short title and commencement

These regulations are called the Under-Serviced Area Definition Regulations, 2011 and shall come into operation on the date of publication in the Gazette.

#### **EXPLANATORY MEMORANDUM**

#### A. INTRODUCTION & BACKGROUND

- (1) This Explanatory Memorandum seeks to contextualize the proposed draft definition of Under-Serviced Areas as contained in the regulations. The definition is required in terms of section 88(2) of the Electronic Communications, 2005 (Act 36 of 2005), as amended (EC Act). The definition is necessary in order to ensure that there is assistance for needy persons towards the cost of the provision to, or the use by them of broadcasting and electronic communications services<sup>1</sup>.
- (2) For purposes of this definition, an area will be under-serviced if the targets for universal access have not been achieved.
- (3) The universal access targets are contained in the determinations of Universal Access and Universal Service, as published by the Minister of Communications ("Minister") in terms of section 82(3) of the Electronic Communications Act, No 36 of 2005, on 8 February 2010 in Government Gazette No 32939.
- (4) The Universal Service and Access Agency of South Africa ("USAASA") had undertaken a public process to define "universal access" and "universal service" in terms of section 82(3) of the ECA and made recommendations to the Minister.
- (5) On 15 August 2008, USAASA published a Discussion Document in Government Gazette No. 31333, which considered in great detail:
  - i. types of needy persons to whom assistance may be given;
  - ii. the persons who may apply for assistance and the manner in which such applications must be made; and
  - iii. the manner in which and persons to whom subsidies may be paid.

- (6) The formulation of the draft definition in the draft regulation took into account the work of the USAASA. As a result, the work done by USAASA is used as a base for the proposed definition.
- (7) In March 2009, in close collaboration with the Department of Communications ("DoC"), ICASA and MDDA, the Agency published a Draft Position Paper and Invitation to a Consultative Workshop, which included refined draft definitions, in Notice 319 of 2009, Government Gazette 32048 dated 20 March 2009. The Agency invited the public to attend a public consultative workshop to discuss the draft definitions, enabling interested parties to consider and discuss with the Agency the revised definitions or provide further comment as necessary.
- (8) The Authority aims to harmonize its approach to the definition of Under-Serviced Areas with the approach adopted by USAASA and the Minister, in the determinations of "universal service" and "universal access". It is against this background that the Authority has adopted the work done by USAASA.
- (9) Further, the draft list of Under-Serviced areas is based on the draft definition, read with the universal access targets contained in the Ministerial determinations. The reason for that is that the goal of government in the short to medium term is to ensure universal access service of ICT services to all the citizens of the Republic.

#### B. CONCLUSION

The Authority hopes for a constructive engagement on the proposals contained herein.
