SUBDIVISION OF AGRICULTURAL LAND ACT, 1970 (ACT No. 70 OF 1970)

**EXCLUSION OF CERTAIN LAND IN THE DISTRICT OF THABAZIMBI FROM THE APPLICATION OF THE ACT**

I, Tina Joemat Pettersson, Minister of Agriculture, acting under paragraph (f) of the definition of "agricultural land" in section 1 of the Subdivision of Agricultural Land Act, 1970 (Act No. 70 of 1970), hereby exclude after consultation with the Executive Committee concerned, the land described in the Schedule, from the provisions of the Act.

Beginning at the north western beacon of Portion 113 of the farm Doornhoek 318 KQ: Thence generally north eastwards to the northern beacon of Portion 36 of the farm Kwaggasvlakte 317 KQ so as to include the area to the south: Thence south wards to the south eastern beacon of Portion 43 of the farm Kwaggasvlakte 317 KQ so as to include the area to the west: Thence generally north eastwards along the northernmost boundary's of the following portions of the farm Marakeli 437 KQ so as to include the mentioned portions and the area to the south thereof: Portion 2, Portion 39, Portion 38, Portion 8, Portion 9, Portion 10, Portion 3 and Portion 6: Thence from the north western beacon of the farm Rra-Ditau 623 KQ, to the southern beacon of Portion 20 of the farm Boschfontein 445 KQ: Thence northwards and south eastwards to include Portion 20 and Portion 1 of the farm Boschfontein 445 KQ: Thence south eastwards, generally southwards, westwards and southwards to include the farm Rra-Ditau 623 KQ up to the south eastern beacon of Portion 3 of the farm Marakeli 437 KQ: Thence westwards up to the south western beacon of Portion 25 and southwards up to the southern beacon of Portion 2 of the farm Marakeli 437 KQ: Thence generally southwards up the south eastern beacon of Portion 16 of the farm Spitskop 346 KQ and south westwards up to the south western beacon of Portion 1 of the farm Spitskop 346 KQ, so as to include all the portions of the farm Spitskop 346 KQ to the north thereof: Thence north west wards along a straight line up to the south eastern beacon of Erf 712, Thabazimbi Extension 5 so as to include a part of the Remainder of the farm Kwaggashoek 345 KQ to the north thereof up to the south western beacon of Erf 715, Thabazimbi Extension 5: Thence south westwards along a straight line up to the northern beacon of Portion 4 of the farm Wachteenbietjedraai 350 KQ so as to include a part of the Remainder of the farm Kwaggashoek 345 KQ: Thence south eastwards and generally south westwards up to the southern beacon of Portion 3 of the farm Wachteenbietjedraai 350 KQ so as to include Portion 3 and 4 of the farm Wachteenbietjedraai 350 KQ: Thence westwards along a straight line up to the southern beacon of Portion 12 of the farm Mooivaley 342 KQ so as to include a part of the Remainder of Portion 10 of the farm Donkerhoek 344 KQ to the north thereof: Thence north eastwards to the north western beacon of the Remainder of Portion 10 of the farm Donkerhoek 344 KQ: Thence north eastwards along a straight line to the south western beacon of the Remainder of Portion 3 of the farm Rosseauspoort 319 KQ so as to include a part of the Remainder of the farm Rosseauspoort 319 KQ to the south thereof: Thence generally northwards and north eastwards up to the northern beacon of the Remainder of Portion 3 of the farm Rosseauspoort 319 KQ so as to include the area to the east therefore: Thence north westwards to the north western beacon of Portion 113 of the farm Doornhoek 318 KQ, the point of beginning.

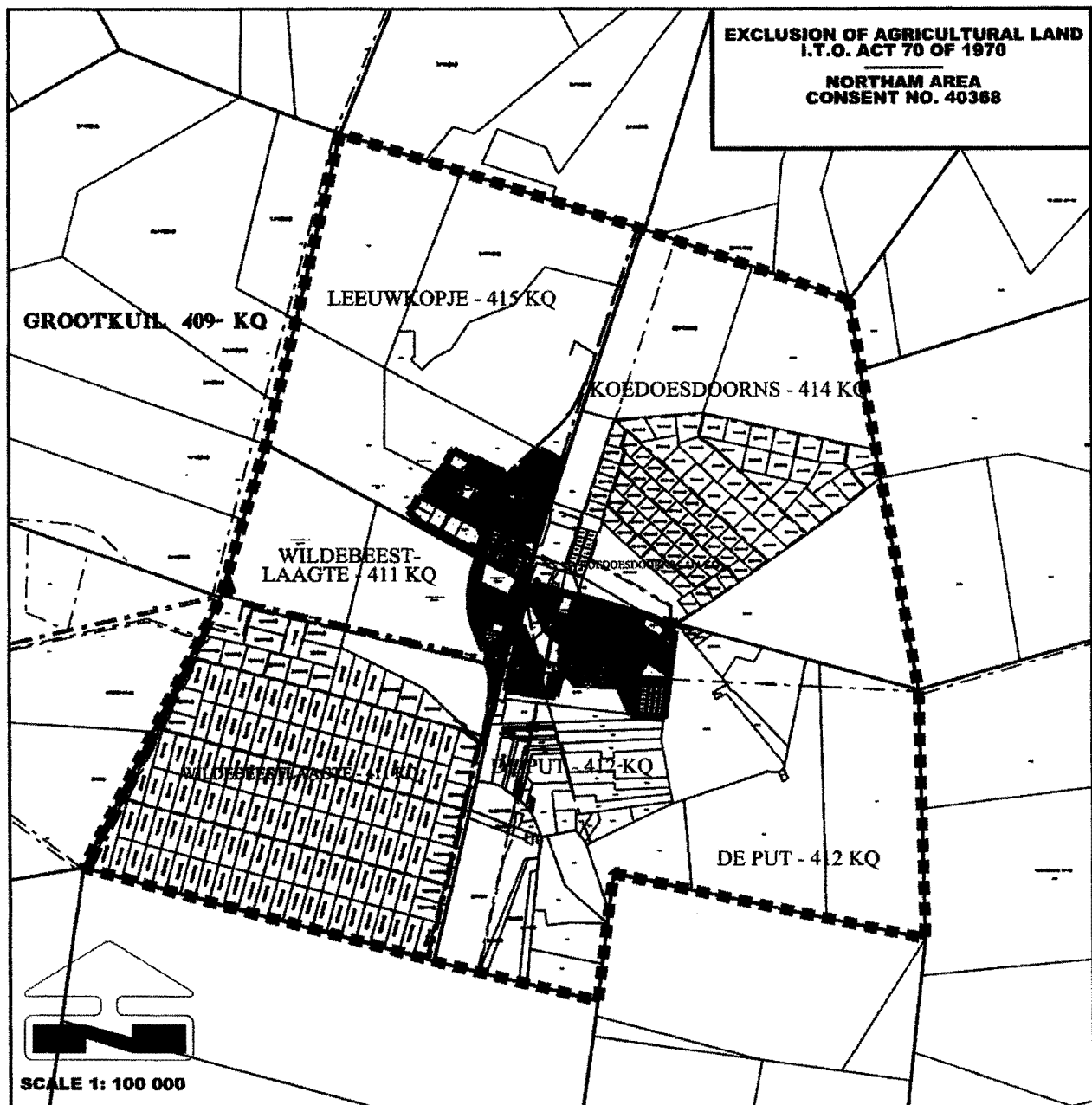
