### CUSTOMS AND EXCISE ACT, 1964. AMENDMENT OF SCHEDULE NO. 1 (NO.1/1/1432)

In terms of section 48 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 1 to the said Act is hereby amended, with effect from 1 January 2012, to the extent set out in the Schedule hereto.

#### SCHEDULE

The column headed "Heading" is deleted and the column headed "Subheading" is renamed to "Heading/Subheading" in Part 1 of Schedule No. 1.

By the substitution of General Note 1(a) in Chapter 1 to Part 1 of Schedule No. 1 of the following:

- (a) fish and crustaceans, molluscs and other aquatic invertebrates, of heading 03.01, 03.06, 03.07 or 03.08;

By the substitution of Subheading Note 2 in Chapter 16 to Part 1 of Schedule No. 1 of the following:

2. The fish, crustaceans, molluscs and other aquatic invertebrates specified in the subheadings of heading 16.04 or 16.05 under their common names only, are of the same species as those mentioned in Chapter 3 under the same name.

By the substitution of the title "Subheading Note" and Subheading Note 1 in Chapter 17 to Part 1 of Schedule No. 1 of the following:

#### SUBHEADING NOTES:

1. For the purposes of subheading 1701.12, 1701.13 and 1701.14 "raw sugar" means sugar whose content of sucrose by mass, in the dry state, corresponds to a polarimeter reading of less than 99,5°

By the insertion of Subheading Note 2 in Chapter 17 to Part 1 of Schedule No. 1 of the following:

2. Subheading 1701.13 covers only cane sugar obtained without centrifugation, whose content of sucrose by mass, in the dry state, corresponds to a polarimeter reading of 69° or more but less than 93°. The product contains only natural anhydrous microcrystals, of irregular shape, not visible to the naked eye, which are surrounded by residues of molasses and other constituents of sugar cane.

By the substitution of Note 3 in Chapter 21 to Part 1 of Schedule No. 1 of the following:

3. For the purposes of heading 21.04, the expression "homogenised composite food preparations" means preparations consisting of a finely homogenised mixture of two or more basic ingredients such as meat, fish, vegetables, fruit or nuts, put up for retail sale as infant food or for dietetic purposes, in containers of a net mass content not exceeding 250 g. For the application of this definition, no account is to be taken of small quantities of any ingredients which may be added to the mixture for seasoning, preservation or other purposes. Such preparations may contain a small quantity of visible pieces of ingredients.

By the insertion of the title "Subheading Note" and Subheading Note 1 in Chapter 24 to Part 1 of Schedule No. 1 of the following:

#### SUBHEADING NOTE:

1. For the purposes of subheading 2403.11, the expression "water pipe tobacco" means tobacco intended for smoking in a water pipe and which consists of a mixture of tobacco and glycerol whether or not containing aromatic oils and extracts, molasses or sugar, and whether or not flavoured with fruit. However, tobacco-free products intended for smoking in a water pipe are excluded from this subheading.

By the substitution of Subheading Note 4 in Chapter 27 to Part 1 of Schedule No. 1 of the following:

4. For the purposes of subheading 2710.12, "light oils and preparations" are those of which 90 per cent or more by volume (including losses) distil at 210°C (ASTM D 86 method).

By the insertion of Subheading Note 5 in Chapter 27 to Part 1 of Schedule No. 1 of the following:

5. For the purposes of the subheadings of heading 27.10, the term "bioliesel" means mono-alkyl esters of fatty acids of a kind used as a fuel, derived from animal or vegetable fats or oils whether or not used.

**By the insertion of the title "Subheading Note" and Subheading Note 1 in Chapter 28 to Part 1 of Schedule No. 1 of the following:**

**SUBHEADING NOTE:**

1. For the purposes of subheading 2852.10, the expression "chemically defined" means all organic or inorganic compounds of mercury meeting the requirements of paragraphs (a) to (e) of Note 1 to Chapter 28 or paragraphs (a) to (h) of Note 1 to Chapter 29.

**By the insertion of new Note 2(e) and relettering current Notes 2(a) to (k) as Notes 2(f) to (l) in Chapter 29 to Part 1 of Schedule No. 1 of the following:**

- (e) immunological products of heading 30.02;
- (f) urea (heading 31.02 or 31.05);
- (g) colouring matter of vegetable or animal origin (heading 32.03), synthetic organic colouring matter, synthetic organic products of a kind used as fluorescent brightening agents or as luminophores (32.04) or dyes or other colouring matter put up in forms or packings for retail sale (heading 32.12);
- (h) enzymes (heading 35.07);
- (i) metaaldehyde, hexamethylenetetramine or similar substances, put up in forms (for example, tablets, sticks or similar forms) for use as fuels, or liquid or liquefied-gas fuels in containers of a kind used for filling or refilling cigarette or similar lighters and of a capacity not exceeding 300 cm<sup>3</sup> (heading 36.06);
- (k) products put up as charges for fire-extinguishers or put up in fire-extinguishing grenades, of heading 38.13; ink removers put up in packings for retail sale, of heading 38.24; or
- (l) optical elements, for example, of ethylenediamine tartrate (heading 90.01).

**By the substitution of Notes 1(a) to (g) and Note 2 in Chapter 30 to Part 1 of Schedule No. 1 of the following:**

- (a) foods or beverages (such as dietetic, diabetic or fortified foods, food supplements, tonic beverages and mineral waters) (excluding nutritional preparations for intravenous administration) (Section IV);
  - (b) preparations, such as tablets, chewing gum or patches (transdermal systems), intended to assist smokers to stop smoking (heading 21.06 or 38.24);
  - (c) plasters specially calcined or finely ground for use in dentistry (heading 25.20);
  - (d) aqueous distillates or aqueous solutions of essential oils, suitable for medicinal uses (heading 33.01);
  - (e) preparations of headings 33.03 to 33.07, even if they have therapeutic or prophylactic properties;
  - (f) soap or other products of heading 34.01 containing added medicaments;
  - (g) preparations with a basis of plaster for use in dentistry (heading 34.07); or
  - (h) blood albumin not prepared for therapeutic or prophylactic uses (heading 35.02).
2. For the purposes of heading 30.02, the expression "immunological products" applies to peptides and proteins (other than goods of heading 29.37) which are directly involved in the regulation of immunological processes, such as monoclonal antibodies (MAB), antibody fragments, antibody conjugates and antibody fragment conjugates, interleukins, interferons (IFN), chemokines and certain tumor necrosis factors (TNF), growth factors (GF), hematopoietins and colony stimulating factors (CSF).

**By the substitution of Note 3(d) in Chapter 38 to Part 1 of Schedule No. 1 of the following:**

- (d) stencil correctors, other correcting fluids and correction tapes (excluding those of heading 96.12) put up in packings for retail sale; and

**By the insertion of Note 7 in Chapter 38 to Part 1 of Schedule No. 1 of the following:**

7. For the purposes of heading 38.26, the term "biodiesel" means mono-alkyl esters of fatty acids of a kind used as a fuel, derived from animal or vegetable fats and oils whether or not used.

By the substitution of Subheading Note 1 in Chapter 38 to Part 1 of Schedule No. 1 of the following:

1. Subheading 3808.50 covers only goods of heading 38.08, containing one or more of the following substances: aldrin (ISO); binapacryl (ISO); camphechlor (ISO) (toxaphene); captafol (ISO); chlordane (ISO); chlordimeform (ISO); chlorobenzilate (ISO); DDT (ISO) (clofenotane (INN), 1,1,1-trichloro-2,2-bis(p-chlorophenyl)ethane); dieldrin (ISO, INN); 4,6-dinitro-o-cresol (DNOC (ISO)) or its salts; dinoseb (ISO), its salts or its esters; ethylene dibromide (ISO) (1,2-dibromoethane); ethylene dichloride (ISO) (1,2-dichloroethane); fluoroacetamide (ISO); heptachlor (ISO); hexachlorobenzene (ISO); 1,2,3,4,5,6-hexachlorocyclohexane (HCH (ISO)), including lindane (ISO, INN); mercury compounds; methamidophos (ISO); monocrotophos (ISO); oxirane (ethylene oxide); parathion (ISO); parathion-methyl (ISO) (methyl-parathion); pentachlorophenol (ISO), its salts or its esters; phosphamidon (ISO); 2,4,5-T (ISO) (2,4,5-trichlorophenoxyacetic acid), its salts or its esters; tributyltin compounds.
- Subheading 3808.50 also covers dustable powder formulations containing a mixture of benomyl (ISO), carbofuran (ISO) and thiram (ISO).

By the substitution of Additional Notes 1(a) to (c) in Chapter 38 to Part 1 of Schedule No. 1 of the following:

- (a) Tariff subheading 3826.00.10 covers biodiesel –
- (i) intended for use, advertised for use, put up for use or otherwise marketed or disposed of for use as a liquid fuel substitute for petroleum based distillate fuels; or
  - (ii) used for blending with petroleum fuels.
- (b) Biodiesel that does not conform to Note 1(a), is to be classified in tariff subheading 3826.00.90.
- (c) Biodiesel classifiable in subheading 3826.00.10 does not include biodiesel blended with petroleum based fuels classifiable in Chapter 27 or elsewhere in this Schedule.

By the insertion of the Note 1 and the renumbering of Notes 1 to 3 as Notes 2 to 4 in Chapter 42 to Part 1 of Schedule No. 1 of the following:

1. For the purposes of this Chapter, the term "leather" includes chamois (including combination chamois) leather, patent leather, patent laminated leather and metallised leather.
2. This Chapter does not cover the following:
  - (a) sterile surgical catgut or similar sterile suture materials (heading 30.06);
  - (b) articles of apparel or clothing accessories (except gloves, mittens and mitts), lined with furskin or artificial fur or to which furskin or artificial fur is attached on the outside except as mere trimming (heading 43.03 or 43.04);
  - (c) made up articles of netting (heading 56.08);
  - (d) articles of Chapter 64;
  - (e) headgear or parts thereof of Chapter 65;
  - (f) whips, riding-crops or other articles of heading 66.02;
  - (g) cuff-links, bracelets or other imitation jewellery (heading 71.17);
  - (h) fittings or trimmings for harness, such as stirrups, bits, horse brasses and buckles, separately presented (generally Section XV);
  - (i) strings, skins for drums or the like, or other parts of musical instruments (heading 92.09);
  - (j) articles of Chapter 94 (for example, furniture, lamps and lighting fittings);
  - (k) articles of Chapter 95 (for example, toys, games, sports requisites); or
  - (l) buttons, press-fasteners, snap-fasteners, press-studs, button moulds or other parts of these articles, button blanks, of heading 96.06.

  - A. In addition to the provisions of Note 1 above, heading 42.02 does not cover:
    - (a) bags made of sheeting of plastics, whether or not printed, with handles, not designed for prolonged use (heading 39.23);
    - (b) articles of plaiting materials (heading 46.02).
  - B. Articles of headings 42.02 and 42.03 which have parts of precious metal or metal clad with precious metal, of natural or cultured pearls, of precious or semi-precious stones (natural synthetic or reconstructed) remain classified in those headings even if such parts constitute more than minor fittings or minor ornamentation, provided that these parts do not give the articles their essential character. If, on the other hand, the parts give the articles their essential character, the articles are to be classified in Chapter 71.
4. For the purposes of heading 42.03, the expression "articles of apparel and clothing accessories" applies, *inter alia*, to gloves, mittens and mitts (including those for sport or for protection), aprons and other protective clothing, braces, belts, bandoliers and wrist straps, but excluding watch straps (heading 91.13).

By the substitution of renumbered Note 3 in Chapter 42 to Part 1 of Schedule No. 1 of the following:

  - A. In addition to the provisions of Note 2 above, heading 42.02 does not cover:

**SUBHEADING NOTES:**

1. For the purposes of subheading 4401.31, the expression "wood pellets" means by-products such as cutter shavings, sawdust or chips, of the mechanical wood processing industry, furniture-making industry or other wood transformation activities, which have been agglomerated either directly by compression or by the addition of a binder in a proportion not exceeding 3% by weight. Such pellets are cylindrical, with a diameter not exceeding 25 mm and a length not exceeding 100 mm.
2. For the purposes of subheadings 4403.41 to 4403.49, 4407.21 to 4407.29, 4408.31 to 4408.39 and 4412.31, the expression "tropical wood" means one of the following types of wood: Abura, Acajou d'Afrique, Afromosia, Ako, Alan, Andiroba, Aningré, Avodiré, Azobé, Balau, Balsa, Bossé clair, Bossé foncé, Cativo, Cedro, Dabema, Dark Red Meranti, Dibétou, Doussié, Framiré, Freijo, Fromager, Fuma, Geronggang, Ilomba, Imbuia, Ipé, Iroko, Jaboty, Jelutong, Jequitiba, Jongkong, Kapur, Kempas, Keruing, Kosipo, Kotibé, Koto, Light Red Meranti, Limba, Louro, Macaranduba, Mahogany, Makoré, Mandioqueira, Mansonia, Mengkulang, Meranti Bakau, Merawan, Merbau, Merpauh, Mersawa, Moabi, Niangon, Nyatoh, Obeche, Okoumé, Onzabli, Orey, Ovengkol, Ozigo, Padauk, Paldao, Palissandre de Guatemala, Palissandre de Para, Palissandre de Rio, Palissandre de Rose, Paw Amarelo, Pau Marfim, Pulai, Puna, Quaruba, Ramin, Sapelli, Saqui-Saqui, Sepetir, Sipo, Sucupira, Suren, Tauani, Teak, Tiama, Tola, Virola, White Lauan, White Meranti, White Seraya, Yellow Meranti.

By the substitution of Note 2(o) and (p) and by the insertion of Note 2(q) in Chapter 48 to Part 1 of Schedule No. 1 of the following:

- (o) articles of heading 92.09;
- (p) articles of Chapter 95 (for example, toys, games, sports requisites); or
- (q) articles of Chapter 96 (for example, buttons, sanitary towels (pads) and tampons, napkins (diapers) and napkin liners for babies).

By the substitution of Subheading Notes 3 and 4 in Chapter 48 to Part 1 of Schedule No. 1 of the following:

3. For the purposes of subheading 4805.11, "semi-chemical fluting paper" means paper, in rolls, of which not less than 65 per cent by mass of the total fibre content consists of unbleached hardwood fibres obtained by a combination of mechanical and chemical pulping processes, and having a CMT 30 (Corrugated Medium Test with 30 minutes of conditioning) crush resistance exceeding 1,8 newtons/g/m<sup>2</sup> at 50 per cent relative humidity, at 23°C.
4. Subheading 4805.12 covers paper, in rolls, made mainly of straw pulp obtained by a combination of mechanical and chemical processes, of a mass of 130 g/m<sup>2</sup> or more, and having a CMT 30 (Corrugated Medium Test with 30 minutes of conditioning) crush resistance exceeding 1,4 newtons/g/m<sup>2</sup> at 50 per cent relative humidity, at 23°C.

By the substitution of Note 1(u) in Section XI to Part 1 of Schedule No. 1 of the following:

- (u) articles of Chapter 96 (for example, brushes, travel sets for sewing, slide fasteners, typewriter ribbons, sanitary towels (pads) and tampons, napkins (diapers) and napkin liners for babies); or

By the insertion of new Note 7(c) and relettering of current Notes 7(c) to (f) as Notes (d) to (g) in Section XI to Part 1 of Schedule No. 1 of the following:

- (c) cut to size and with at least one heat-sealed edge with a visibly tapered or compressed border and the other edges treated as described in any other subparagraph of this Note, but excluding fabrics the cut edges of which have been prevented from unravelling by hot cutting or by other simple means;
- (d) hemmed or with rolled edges, or with a knotted fringe at any of the edges, but excluding fabrics the cut edges of which have been prevented from unravelling by whipping or by other simple means;
- (e) cut to size and having undergone a process of drawn thread work;
- (f) assembled by sewing, gumming or otherwise (excluding piece goods consisting of two or more lengths of identical material joined end to end and piece goods composed of two or more textiles assembled in layers, whether or not padded);
- (g) knitted or crocheted to shape, whether presented as separate items or in the form of a number of items in the length.

**By the substitution of Note 1(d) and 1(e) and the insertion of Note 1(f) in Chapter 56 to Part 1 of Schedule No. 1 of the following:**

- (d) agglomerated or reconstituted mica, on a backing of felt or nonwovens (heading 68.14);
- (e) metal foil on a backing of felt or nonwovens (generally Section XIV or XV); or
- (f) sanitary towels (pads) and tampons, napkins and napkin liners for babies and similar articles of heading 96.19.

**By the substitution of Note 6(a) in Chapter 61 to Part 1 of Schedule No. 1 of the following:**

- (a) the expression "babies' garments and clothing accessories" means articles for young children of a body height not exceeding 86 cm;

**By the substitution of Note 4(a) in Chapter 62 to Part 1 of Schedule No. 1 of the following:**

- (a) the expression "babies' garments and clothing accessories" means articles for young children of a body height not exceeding 86 cm;

**By the substitution of Note 3(e) in Chapter 71 to Part 1 of Schedule No. 1 of the following:**

- (e) articles of heading 42.02 or 42.03 referred to in Note 3(B) to Chapter 42;

**By the substitution of Note 1(a) in Section XVI to Part 1 of Schedule No. 1 of the following:**

- (a) Transmission or conveyor belts or belting, of plastics of Chapter 39, or of vulcanised rubber (heading 40.10), or other articles of a kind used in machinery or mechanical or electrical appliances or for other technical uses, of vulcanised rubber(excluding hard rubber) (heading 40.16);

Subject to the operation of Note 3 to Section XVI and subject to Note 9 to this Chapter, a machine or appliance which answers to a description in one or more of the headings 84.01 to 84.24, or heading 84.86 and at the same time to a description in one or other of the headings 84.25 to 84.80 is to be classified under the appropriate heading of the former group or under heading 84.86, as the case may be, and not the latter group  
 Heading 84.19 does not, however, cover:
  - (a) germination plant, incubators or brooders (heading 84.36);
  - (b) grain dampening machines (heading 84.37);
  - (c) diffusing apparatus for sugar juice extraction (heading 84.38);

  - (b) water-jet cutting machines (heading 84.56).

- (ii) assembling semiconductor device or electronic integrated circuits;

1. For the purposes of subheading 8471.49, the term "system" means automatic data processing machines whose units satisfy the conditions laid down in Note 5(C) to Chapter 84 and which comprise at least a central processing unit, one input unit (for example, a keyboard or a scanner), and one output unit (for example, a visual display unit or a printer).

**By the substitution of Note 1(d) in Chapter 85 to Part 1 of Schedule No. 1 of the following:**

- (d) vacuum apparatus of a kind used in medical, surgical, dental or veterinary sciences (heading 90.18); or

**By the substitution of Note 1(g) in Chapter 94 to Part 1 of Schedule No. 1 of the following:**

- (g) furniture specially designed as parts of apparatus of heading 85.18 (heading 85.18), of heading 85.19 or 85.21 (heading 85.22) or of heading 85.25 to 85.28 (heading 85.29);

**By the substitution of Note 2(a) in Chapter 94 to Part 1 of Schedule No. 1 of the following:**

- (a) cupboards, bookcases, other shelved furniture (including single shelves presented with supports for fixing them to the wall) and unit furniture;

**By the substitution of Note 1(m) in Chapter 95 to Part 1 of Schedule No. 1 of the following:**

- (m) pumps for liquids (heading 84.13), filtering or purifying machinery and apparatus for liquids or gases (heading 84.21), electric motors (heading 85.01), electric transformers (heading 85.04), discs, tapes, solid-state non-volatile storage devices, "smart cards" and other media for the recording of sound or of other phenomena whether or not recorded (heading 85.23), radio remote control apparatus (heading 85.26) or cordless infrared remote control devices (heading 85.43);

**By the insertion of the title "Subheading Note" and Subheading Notes 1 (a) and (b) in Chapter 95 to Part 1 of Schedule No. 1 of the following:**

**SUBHEADING NOTE:**

1. Subheading 9504.50 covers:

- (a) Video game consoles from which the image is reproduced on a television receiver, a monitor or other external screen or surface; or
