

NOTICE 895 OF 2011**AMENDMENT OF GAZETTE NOTICE 1143****NOTICE AMENDEMENT OF THE GENERAL NOTICE IN TERMS OF THE SECTION 11 (4) OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED**

Notice is hereby given in terms of Section 11A (4) that an amendment be made to the Gazette Notice 1143 of 2000, Government Gazette No. 20974 of land claimed by Mamahlola Community.

The amendment of the above mentioned notice is made to include portions of the farm Murle Brooke 651 LT.

Mr. Frans Maselo Makwela lodged a land claim on the 28th December 1998 on behalf of the Mamahlola Community. The Mamahlola land claim was accepted as prom facie and published in Government gazette notice 1143 of 2000, number 20974. The properties gazetted were Mamathola 609 LT, Monavein 612 LT, Litwalo 642 LT and Mamathola's Location 635 LT.

However, it was discovered that the farm Murle Brooke 651 LT was erroneously omitted in the previous gazette. Therefore the gazette of 2000 should be amended to include the farm Murle Brooke 651 LT.

The gazette is amended and current sub-divisions of the aforementioned properties appear as described in the table below:
