

**NOTICE 896 OF 2011****AMENDMENT OF GAZETTE NOTICE 29950****NOTICE AMENDEMENT OF THE GENERAL NOTICE IN TERMS OF THE SECTION 11 (4) OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED**

Notice is hereby given in terms of Section 11A (4) that an amendment be made to the Gazette Notice 723 of 2007 Gazette No. 29950 of land claimed by Balepye community.

The amendment of the above mentioned notice is made to include portions of the farm Grootfontein 832 LT and Grootfontein 738 LT.

The claim for restitution of land rights has been lodged by Mr.MS Kgoatla on behalf of Balepye Kgoatla community on the 9<sup>th</sup> of November 1998. The claim was lodged on different farms in the Baphalaborwa Municipality including the above mentioned farms which were erroneously omitted in the previous gazette. Therefore this gazette is amended to include the farm Grootfontein 832 LT.

In the previous gazettes of Balepye, Grootfontein 738 LT was gazetted; however an omission was made for not including Grootfontein 832 LT. Therefore the amendment will be to include the farm Grootfontein 832 LT as part of all the other farms claimed by Balepye Community.

The gazette is amended and current sub-divisions of the aforementioned properties appear as described in the table below:
