CALL FOR PUBLIC COMMENT

Proposed Annual Fees for the financial year 1 April 2012 - 31 March 2013 in terms of the Architectural Profession Act, No 44 of 2000

The South African Council for the Architectural Profession (SACAP) is empowered in terms of Section 12 (1) of the Architectural Profession Act, Act No. 44 of 2000 to charge annual registration fees. Section 12 (i), of the Act also makes provision for SACAP to charge fees for other services and prescribe the rules relating to the payment of fees and charges for registered persons.

Taking into consideration inputs received by SACAP from interested and affected persons, including SACAP Registered Persons, Stakeholders and SACAP recognised Voluntary Associations (VA's), the prescribed annual fees for the 2012-2013 financial year will be adjusted by 5%. All other corresponding and related fees and charges have been similarly adjusted.

SACAP hereby advises interested and affected persons that the proposed adjustment to annual fees and charged for other services is herewith gazetted for public comment in terms of Section 12 (1) of the Architectural Profession Act, Act No. 44 of 2000.

Closing date for public comment is: 12h00 on Monday, 5 March 2012.

- Final annual fees and charges will be published per Board Notice in the Government Gazette and will replace and supersede the Board Notice 97 of 2011, published 20 May 2011
- The Council may suspend the registration of a Registered Person if he/she fails pay the
 prescribed annual fee or portion thereof within 60 days of it becoming due or within such period
 that the Council may allow.
- Please note that the Council will not be offering any form of rebates and/or discounts to Registered Persons for the current financial year.
