29839 IN RESPECT OF ROKA MOTSHANA TRIBE LAND CLAIM**

Notice is hereby given in terms of Section 11A (4) of the Restitution of Land Rights Act, 1994 (Act No. 22 of 1994), as amended, that an amendment is hereby made to Gazette notice No. 510 of 2007 contained in Government Gazette No. 29839, dated 04 May 2007.

Messer Ms Mampe Roster Komana lodged a land claim on behalf of Roka Motshana Local Government on the 13th December 1998 on Zamenloop 134 KT, Kromellenboog 132 KT, Kranskloof 131 KT, Haakdoornhoek 262 KT, Weltevreden 130 KT, Diepkloof 129 KT, Zonneschyn 128 KT, Morgenzon 125 KT, Naboomkoppies 263 KT, Penge 108 KT and Riverside 107 KT and was allocated KRP 5533.
