4. Persons who make such representations must indicate in their written representations whether they require an opportunity to make oral representations in the event the Authority decides to hold hearings.

Persons who submit representations in terms of this notice shall, when submitting such representations, provide proof to the satisfaction of the Authority that a copy of the representations submitted has been sent by registered mail or by facsimile, or delivered to the persons mentioned in the schedule below.
6. The applicants shall be entitled to respond in writing to the written representations made by any interested persons, and such written response must be lodged with the Authority within twenty one (21) working days after the closing date of the written representation. The applicant must, at the time of lodging such written response, furnish to the Authority's satisfaction that it has delivered a copy of such response by hand or has sent a copy of such response by registered mail or facsimile to the relevant person having made such written representation.


