# APPLICATION FOR REGISTRATION OF HERALDIC REPRESENTATIONS AND OBJECTIONS THERETO

# SECTIONS 7, 7A AND 7B OF THE HERALDRY ACT, 1962 (ACT NO. 18 OF 1962)

The undermentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for the registration of their heraldic representations. Anyone wishing to object to the registration of these heraldic representations on the grounds that such registrations will encroach upon rights to which he or she is legally entitled should do so within one month of the date of publication of this notice upon a form obtainable from the State Herald, Private Bag X236, Pretoria, 0001.

## 1. APPLICANT: Family Association of the Barons Von Quast (H4/3/1/4136)

**ARMS:** Gules a fillet saltire Or, between in chief three escallops placed two and one of the second, dexter issuant from the shield edge an arm vambraced Argent ,holding an anchor Or, sinister a ship Or, with sails hoisted Argent, and in base a double-headed eagle Or, in each claw a mullet of six points Argent; a chief erminois.

## 2. APPLICANT: Peter Berry Ottaway (H4/3/4/984)

ARMS: Azure, a chevron the upper edge dovetailed Argent, charged with a filletchevron of the first, between in chief two garbs, and in base a fleur-de-lis all Or.
CREST: Upon an astral crown a fish eagle risant, in his claws a trout all proper.
WREATH AND MANTLING: Azure and Argent.
MOTTO: STRIVING EVER UPWARDS

#### 3. APPLICANT: Sameule Maria Giorgio (H4/3/4/985)

**ARMS:** Per bend sinister Gules and Or, in chief a lion rampant contourné Or and in base a griffin segreant Gules.

**CREST:** Issuant from a crest coronet a demi-lion rampant Or.

WREATH AND MANTLING: Gules and Or.

**MOTTO: MORES ET HONORES** 

#### 4. APPLICANT: Ezra Juchter van Bergen Quast (H4/3/4/986)

**ARMS:** Gules a fillet saltire Or, between in chief three escallops placed two and one of the second, dexter issuant from the shield edge an arm vambraced Argent ,holding an anchor Or, sinister a ship Or, with sails hoisted Argent, and in base a double-headed eagle Or, in each claw a mullet of six points Argent; on a chief erminois a leopards head and neck erased Gules holding in its mouth a Dutch East-India Keris dagger proper.

#### 5. APPLICANT: Roselien Ashakoemarie Kishna (H4/3/4/988).

**ARMS:** Gules a fillet saltire Or, between in chief three escallops placed two and one of the second, dexter issuant from the shield edge an arm vambraced Argent, holding an anchor Or, sinister a ship Or, with sails hoisted Argent, and in base a double-headed eagle Or, in each claw a mullet of six points Argent; on a chief erminois a rose Gules, seeded and barbed Vert.
