| (aa) | For 1 000 litres eligible purchases -
1 000 X 80 per cent equals 800 litres on which a refund of 187.8 cents per litre may be claimed; |
| (bb) | For 1 000 litres purchased of which 300 litres represent non-eligible purchases, for example, carriage of goods for reward -
1 000 litres less 300 litres equals 700 litres eligible purchases X 80 per cent equals 560 litres on which a refund of 187.8 cents per litre may be claimed; |
