Explanatory Memorandum to the Provincial Allocations set out in the Schedule

This *Gazette* is published in terms of the Division of Revenue Act, 2013 (Act No. 2 of 2013), as amended, and provides information on adjustments to existing allocations to provinces in the 2013/14 financial year.

This is necessitated by the need to stop the flow of funds in terms of Section 18 of the Division of Revenue Act, 2013, as amended, and the need to re-allocate the stopped funds to provinces, as approved in terms of Section 19 of the Division of Revenue Act, 2013, as amended.

This *Gazette* therefore updates information that was published in the Division of Revenue Amendment Act, 2013.

This notice affects the Provincial Roads Maintenance grant, the Community Library Services Grant and the Human Settlements Development Grant

- a) In compliance with Section 18 of the Division of Revenue Act, 2013, as amended, the national Department of Transport stops the transfer of funds to Limpopo (R637.459 million) for the Provincial Roads Maintenance Grant, following revised allocations by the national Department of Transport.
- b) In compliance with Section 19 of the Division of Revenue Act, 2013, as amended, the national Department of Transport re-allocates funds to Free State (R449.74 million) and Northern Cape (R187.719 million) for the Provincial Roads Maintenance Grant, following revised allocations by the national Department of Transport.
- c) In compliance with Section 18 of the Division of Revenue Act, 2013, as amended, the national Department of Arts and Culture stops the transfer of funds to Limpopo (R8.967million) for the Community Library Services grant, following revised allocations by the national Department of Arts and Culture.
- d) In compliance with Section 19 of the Division of Revenue Act, 2013, as amended, the national Department of Arts and Culture re-allocates funds to Free State (R1.483 million), Gauteng (R3 million) and Western Cape (R1.484 million) for the Community Library Services grant, following revised allocations by the national Department of Arts and Culture
- e) In compliance with Section 18 of the Division of Revenue Act, 2013, as amended, the national Department of Human Settlements stops the transfer of funds to Limpopo (R644 million) for the Human Settlements Development grant, following revised allocations by the national Department Human Settlements.
- f) In compliance with Section 19 of the Division of Revenue Act, 2013, as amended, the national Department of Human Settlements re-allocates funds to KwaZulu-Natal (R57 million), Northern Cape (R207.9 million), North West (R117 million), Western Cape (R32.1 million) and Free State (R230 million) for the Human Settlements Development grant, following revised allocations by the national Department Human Settlements.
