

NOTICE 746 OF 2014**GENERAL NOTICE IN TERMS OF SECTION 11 A (4) OF THE RESTITUTION OF LAND RIGHTS ACT, NO. 22 OF 1994 (AS AMENDED).**

WHEREAS a land claim was lodged by Gwigwi Zungu, which claim was published in terms of Section 11(1) of the Restitution of Land Rights Act , No, 22 of 1994 (as amended), hereinafter referred to as "the Act".

and

WHEREAS during further investigation of the land claim in so far as it relates to the properties referred to in the schedule below, Regional Land Claims Commissioner, has reason to believe that the inclusion of the properties in the Government Gazette No. 23125, under Notice 241 of 2002 dated the 22nd of February 2002, was done in error.

NOW THEREFORE NOTICE is hereby given in terms of Section 11A (4) of the Act that the said Notice in Gazette No. 23125 under Notice 241 of 2002 is hereby amended in order to correct the obvious error, by the exclusion of the said properties from the Notice.
