REPEAL OF LOCAL GOVERNMENT LAWS ACT, 1997

# ACT

To repeal certain laws pertaining to local government; and to provide for matters connected therewith.

(Afrikaans text signed by the President.) (Assented to 25 September 1997.)

**B** E IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

### **Repeal of laws**

**1.** The laws mentioned in the Schedule are hereby repealed to the extent set out in the third column of the Schedule.

#### Short title

2. This Act shall be called the Repeal of Local Government Laws Act, 1997.
