### **ACT**

To amend the Insurance Act, 1943, so as to prevent foreigners from conducting unauthorised insurance business in the Republic; and to provide for matters connected therewith.

**B**<sup>E</sup> IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

- 1. Section 1 of the Insurance Act, 1943, is hereby amended—
  - (a) by the substitution for paragraph (c) of subsection (2) of the following paragraph:
    - "(c) a person shall, save in respect of business accepted by him by way of reinsurance, be deemed to be carrying on insurance business in the Republic if he is liable under a [domestic] policy falling within any class of long-term insurance business or related miscellaneous business—
      - (i) applied for in the Republic; or
      - (ii) entered into or altered because of inducement in the Republic by any person;"; and
  - (b) by the deletion  $\overline{\text{of par}}$  agraph (e) of subsection (2).

#### Short title

2. This Act is called the Insurance Amendment Act, 1998.
