### ACT

To amend the Police Act, 1958, so as to provide for officers or employees who are in terms of the provisions of the Public Service Act, 1984, appointed in or transferred to the South African Police; and to provide for matters connected therewith.

(Afrikaans text signed by the State President.) (Assented to 26 February 1993.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 33 of Act 7 of 1958, as amended by section 8 of Act 53 of 1961, section 19 of Act 64 of 1964, section 1 of Act 80 of 1970, section 5 of Act 94 of 1972, section 1 of Act 47 of 1981, section 46 of Act 97 of 1986, section 6 of Act 8 of 1988, section 3 of Act 75 of 1989, section 3 of Act 76 of 1989 and section 13 of Act 87 of 1991

1. Section 33 of the Police Act, 1958, is hereby amended by the insertion in subsection (1) after paragraph  $(\nu)$  of the following paragraph:

"(vA) the necessary consequential adjustments in relation to command, control, powers and duties, by virtue of the appointment or transfer in terms of the Public Service Act, 1984 (Act No. 111 of 1984), of officers or employees in or to the South African Police;".

#### Short title and commencement

2. This Act shall be called the Police Amendment Act, 1993, and shall come into operation on a date fixed by the State President by proclamation in the Gazette.
