(4) A traditional leader is a person identified by the Minister by notice in the *Gazette* for the purposes of this Act.

<sup>(</sup>xii) "traditional leader" means any person identified in terms of section 5(4).

#### CLAUSE 7

- 1. On page 12, from line 3, to omit paragraph (d).

(5) The salaries and allowances paid to and the benefits paid on behalf of a member of a Municipal Council in terms of a law, prior to the coming into operation of this Act. shall be deemed to have been determined under this Act. '

#### CLAUSE 8

- 1. On page 12, in line 39, after "law" to insert "or rules".
- 2. On page 12, in line 42, to omit ", subject to any law,".
- 3. On page 12, from line 44, to omit "form a charge against the National Revenue Fund or".
- 4. On page 12, in line 46, to omit ", as the case may be".
- 5. On page 12, from line 52, to omit "form a charge against the Provincial Revenue Fund" and to substitute:

be paid from monies appropriated for that purpose by the provincial legislature concerned

- 6. On page 14, in line 1, to omit "Premier of the province concerned" and to substitute "Minister of Finance".
- 7. On page 14, in line 2, to omit "Provincial".

(5) (a) The upper limit of the contribution to be made to the pension fund of which a member of a Municipal Council is a member, shall be determined by the Minister after consultation with the pension fund concerned and after taking into consideration the recommendations of the Commission.

(b) The Minister, after consultation with the pension fund concerned, shall determine the amount of the contribution and such amount shall annually form a charge against and be paid from the budget of the municipality concerned.

(6) The provisions of this section shall not apply to a traditional leader, a member of a provincial House of Traditional Leaders and a member of the Council of Traditional Leaders.

(b) The Minister, after consultation with the medical aid scheme concerned, shall determine the amount of the contribution and such amount shall annually form a charge against and be paid from the budget of the municipality concerned.

4. On page 14, from line 43, to omit subsection (6) and to substitute:

(6) The provisions of this section shall not apply to a traditional leader, a member of a provincial House of **Traditional** Leaders and a member of the Council of Traditional Leaders.
