CLAUSE 13

Clause rejected.

NEW CLAUSE

1. That the following be a new Clause:

Substitution of section 89 of Act 61 of 1973

13. The following section is hereby substituted for section 89 of the principal Act:

"Subsidiaries may acquire certain shares in holding company

89. Subsidiary companies may *mutatis mutandis* in accordance with sections 85, 86, 87 and 88, acquire shares in their holding company to a maximum of 10 per cent in the aggregate of the number of issued shares of the holding company: Provided that this section shall not apply to the acquisition of shares by a holding company in a subsidiary of itself.".

CLAUSE 16

- 1. On page 12, in line 49, after "shall" to insert:
 - , at the end of every three month period after 30 June 1999,
- 2. On page 12, in line 50, to omit all the words after "securities" up to and including "issuer" in line 53 and to substitute:
 - and the number and class of securities issued by that issuer held on behalf of each such person
- 3. On page 14, in line 1, to omit "so as to be received by the issuer".
- 4. On page 14, in line 1, to omit all the words after the second "the" up to and including "shareholder" in line 2 and to substitute:
 - end of the three month period referred to in that subsection
- 5. On page 14, in line 27, after "fails" to insert:
 - to comply with any provision of this section or
- 6. On page 14, in line 28, to omit all the words after "disclosure," up to and including "securities" in line 34 and to substitute:
 - shall be guilty of an offence

- 7. On page 14, from line 35, to omit subsection (10).
- 8. On page 14, from line 44, to omit subsection (2).

CLAUSE 21

- On page 26, after line 6, to insert: 1.

 - (a) by the substitution for paragraph (d) of subsection (1) of the following paragraph:

 "(d) in section 37, 140A, 143, 145, 145A, 146, 146A, 147(2)(a), 148, 149, 153(4), 156, 162, 169, 218, 219, 255, 256(5), 260, 284, 424 or 440D(3) or (4), to a fine or to imprisonment for a period not exceeding two years or to both such fine and such imprisonment;";
